## For An Act To Be Entitled

8 AN ACT CONCERNING THE ESTABLISHMENT OF A STATE  
9 DISTRICT COURT TO BE COMPOSED OF ASHLEY COUNTY TO BE  
10 KNOWN AS THE "TWENTY-SIXTH JUDICIAL DISTRICT";  
11 CONCERNING THE ESTABLISHMENT OF A STATE DISTRICT  
12 COURT TO BE COMPOSED OF BRADLEY AND DREW COUNTIES TO  
13 BE KNOWN AS THE "TWENTY-EIGHTH JUDICIAL DISTRICT";  
14 AND FOR OTHER PURPOSES.

18 CONCERNING THE ESTABLISHMENT OF STATE  
19 DISTRICT COURTS IN ASHLEY, BRADLEY, AND  
20 DREW COUNTIES.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. Arkansas Code § 16-17-1112(b), concerning the district  
26 courts that will become state district courts as of January 1, 2017, is  
27 amended to add two new subdivisions to read as follows:

28 (8)(A) The Twenty-Sixth District shall be composed of Ashley  
29 County.

30 (B) The Twenty-Sixth District shall have two (2)  
31 departments as follows:

32 (i) One (1) located in Crossett; and

33 (ii) One (1) located in Hamburg.

34 (C) The Twenty-Sixth District shall be served by one (1)  
35 state district court judge.

36 (D) The Twenty-Sixth District judge shall be elected



1 districtwide.

2 (E) The Twenty-Sixth District courts shall have district-  
3 wide jurisdiction; and

4 (9)(A) The Twenty-Eighth District shall be composed of Bradley  
5 and Drew counties.

6 (B) The Twenty-Eighth District shall have two (2)  
7 departments as follows:

8 (i) One (1) located in Monticello; and

9 (ii) One (1) located in Warren.

10 (C) The Twenty-Eighth District shall be served by one (1)  
11 state district court judge.

12 (D) The Twenty-Eighth District judge shall be elected  
13 districtwide.

14 (E) The Twenty-Eighth District courts shall have district-  
15 wide jurisdiction.
