## For An Act To Be Entitled

8 AN ACT TO PROVIDE ADDITIONAL COMPENSATION TO A  
9 TEACHER IN GRADES SEVEN THROUGH TWELVE (7-12) WHO  
10 ELECTS TO TEACH MORE THAN THE MAXIMUM NUMBER OF  
11 STUDENTS PERMITTED UNDER THE STANDARDS FOR  
12 ACCREDITATION OF ARKANSAS PUBLIC SCHOOLS AND SCHOOL  
13 DISTRICTS; AND FOR OTHER PURPOSES.

## Subtitle

17 TO PROVIDE ADDITIONAL COMPENSATION TO A  
18 TEACHER IN GRADES SEVEN THROUGH TWELVE  
19 (7-12) WHO ELECTS TO TEACH MORE THAN THE  
20 MAXIMUM NUMBER OF STUDENTS PERMITTED.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 *SECTION 1. Arkansas Code Title 6, Chapter 17, Subchapter 8, is amended*  
26 *to add an additional section to read as follows:*

27 *6-17-812. Compensation for teaching more than the maximum number of*  
28 *students permitted.*

29 *(a)(1) If a teacher in grades seven through twelve (7-12) volunteers*  
30 *to teach more than the maximum number of students permitted per day under the*  
31 *Standards for Accreditation of Arkansas Public Schools and School Districts,*  
32 *then the teacher's pay under his or her contract shall be increased by an*  
33 *amount proportionate to the teacher's base pay and the additional number of*  
34 *students taught by the teacher.*

35 *(2) Subdivision (a)(1) of this section permits a teacher to*  
36 *volunteer to teach more than the maximum number of students permitted per day*



1 under the Standards for Accreditation of Arkansas Public Schools and School  
2 Districts but does not permit a teacher to exceed the maximum class size  
3 permitted under the Standards for Accreditation of Arkansas Public Schools  
4 and School Districts.

5 (3) A teacher in grades seven through twelve (7-12) may  
6 volunteer to use his or her conference period during the day to teach an  
7 additional class period or to teach more than the maximum number of students  
8 per day and shall be compensated at a pro-rated portion of his or her  
9 contract for both the extra class period and for every additional student  
10 they teach over the maximum number of students permitted per day under the  
11 Standards for Accreditation of Arkansas Public Schools and School Districts.

12 (b)(1) A teacher is not required to teach more than the maximum number  
13 of students permitted per day under the Standards for Accreditation of  
14 Arkansas Public Schools and School Districts but a teacher may voluntarily  
15 teach more than the maximum number of students permitted per day.

16 (2) A teacher who volunteers under subsection (a) of this  
17 section shall sign an agreement with the school district for the additional  
18 compensation that is applicable to the semester in which the teacher  
19 volunteers to teach more than the maximum number of students permitted per  
20 day under the Standards for Accreditation of Arkansas Public Schools and  
21 School Districts.

22 (3)(A) Neither the school district or the teacher are obligated  
23 to enter into or renew an agreement or continue an agreement past the  
24 semester in which the agreement is signed.

25 (B) An agreement between the teacher and the school  
26 district shall be signed before any additional compensation is provided.

27 (C) The provisions of § 6-17-1501 et seq. do not apply to  
28 an agreement entered into between a teacher and a school district under this  
29 section.

30 (4) A public school or school district that enters into, renews,  
31 or continues an agreement with a teacher under this section is not in  
32 violation of the Standards of Accreditation of Arkansas Public Schools and  
33 School Districts because the teacher teaches more than the maximum number of  
34 students per day.

35 (c) A school district shall adopt a policy to implement this section.
