18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. Arkansas Code § 5-36-103(b)(3)(A), concerning the amount of
21 money that constitutes theft of property that is a Class D felony, is amended
22 to read as follows:

23 (A) The value of the property is five thousand dollars
24 (\$5,000) or less but more than ~~one thousand dollars (\$1,000)~~ five hundred
25 dollars (\$500);

27 SECTION 2. Arkansas Code § 5-36-103(b)(4)(A), concerning the amount of
28 money that constitutes misdemeanor theft of property, is amended to read as
29 follows:

30 (A) The value of the property is ~~one thousand dollars~~
31 ~~(\$1,000)~~ five hundred dollars (\$500) or less; or

33 SECTION 3. Arkansas Code § 5-36-104(c)(3), concerning the amount of
34 money that constitutes theft of services that is a Class D felony, is amended
35 to read as follows:

36 (3) Class D felony if the value of the service is five thousand



1 dollars (\$5,000) or less but more than ~~one thousand dollars (\$1,000)~~ five
2 hundred dollars (\$500); or

4 SECTION 4. Arkansas Code § 5-36-105(b), concerning the amount of money
5 that constitutes theft of property that is lost, mislaid, or delivered by
6 mistaken that is a Class D felony, is amended to read as follows:

7 (b) Theft of property lost, mislaid, or delivered by mistake is a:

8 (1) Class D felony if the value of the property is ~~one thousand~~
9 ~~dollars (\$1,000)~~ five hundred dollars (\$500) or more; or

10 (2) Class B misdemeanor if:

11 (A) The value of the property is less than ~~one thousand~~
12 ~~dollars (\$1,000)~~ but more than five hundred dollars (\$500); or

13 (B) The property is a:

14 (i) Credit card or credit card account number; or

15 (ii) Debit card or debit card account number; ~~or,~~

16 ~~(3) Class C misdemeanor if otherwise committed.~~

18 SECTION 5. Arkansas Code § 5-36-106(e)(3)(A), concerning the amount of
19 money that constitutes theft by receiving that is a Class D felony, is
20 amended to read as follows:

21 (A) The value of the property is five thousand dollars
22 (\$5,000) or less but more than ~~one thousand dollars (\$1,000)~~ five hundred
23 dollars (\$500);
