Arkansas Code § 28-65-702(b)(1), concerning the appointment 3 of the Public Guardian for Adults, is amended to read as follows: 4 (b)(1) In addition to the qualifications required under § 28-65-203, 5 the public guardian shall: 6 (A) Hold a degree in law or social work or a related 7 field; 8 (B) Submit to a criminal background check with 9 satisfactory results as prescribed by the division department; 10 (C) Attend and complete at least twenty (20) hours of 11 training approved by the division department; and 12 (D) Demonstrate competency and ability to carry out the 13 values of the ward. 14 15 SECTION 4. Arkansas Code § 28-65-703, concerning the duties of the 16 Public Guardian for Adults, is amended to add an additional subsection to 17 read as follows: 18 (h)(1) Upon petition by the Department of Human Services, a court may 19 direct payment from the assets of the ward for services rendered or goods 20 purchased by or for the ward during the course of the guardianship. 21 (2) Notwithstanding the requirement of § 28-51-303(b)(2)(A), the 22 court may allow the sale of a ward's property at public auction for less than 23 three-fourths (3/4) of the appraised value. 24 25 SECTION 5. Arkansas Code § 28-65-705 is amended to read as follows: 26 28-65-705.
