17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code § 17-87-312(e), concerning offenses that
20 prohibit nursing licensure, is amended to read as follows:

21 (e) Except as provided in subdivision (1)(1) of this section, ~~ne a~~
22 person shall not be eligible to receive or hold a license issued by the board
23 if that person has pleaded guilty or nolo contendere to or has been found
24 guilty of any of the following offenses by ~~any a~~ a court in the State of
25 Arkansas or of any similar offense by a court in another state or of any
26 similar offense by a federal court:
