33	SECTION 1. Arkansas Coo	de § 27-14-412, concerning	g records of the Office
34	of Motor Vehicle, is amended	co read as follows:

36	(a)(l) All records of t	the Office of Motor Vehic	le, other than those

- l declared by law to be confidential for the use of the office, shall be open
- 2 to public inspection during office hours.
- 3 (2) The use of lists or other aggregations of compilations of
- 4 motor vehicle registration information is restricted to safety recall
- 5 notification programs involving motor vehicles and motor vehicle equipment,
- 6 other federal and state agency programs, and research and statistics
- 7 involving motor vehicles in which individual identities are not published,
- 8 disclosed, or for any other purpose authorized by the Driver's Privacy
- 9 Protection Act of 1994, 18 U.S.C. § § 2721 2725, as it existed on January
- 10 1, 2015.
- 11 (3) Motor vehicle registration information shall not be sold,
- 12 furnished, or used for solicitation purposes.
- 13 (b)(1) The Commissioner of Motor Vehicles and such officers of the
- 14 office as the commissioner may designate are authorized to prepare under the
- 15 seal of the office and deliver upon request a certified copy of any record of
- 16 the office or a noncertified electronic copy of any record of the office.
- 17 (2) A fee of one dollar (\$1.00) shall be charged for each
- 18 document so certified record authenticated.
- 19 (3) Every such certified copy shall be admissible in any
- 20 proceeding in any court in like manner as the original.
- 21 (4) A party requesting a noncertified electronic record shall
- 22 execute a written agreement with the Department of Finance and Administration
- 23 that includes the following provisions:
- 24 (A) An acknowledgment that the party requesting a record
- 25 <u>shall comply with all state and federal limits on the use of those records;</u>
- 26 <u>(B) An agreement that the party seeking to obtain records</u>
- 27 shall hold harmless and indemnify the Department of Finance and
- 28 Administration for any money damages, punitive damages, criminal fines, civil
- 29 penalties, court costs, and attorney's fees awarded to any person or entity
- 30 by any state or federal court or by the Arkansas State Claims Commission
- 31 resulting from any disclosure by the party of motor vehicle information that
- 32 is contrary to state or federal law; and
- 33 (C) A fee of not less than twenty dollars and fifty cents
- 34 (\$20.50) nor more than thirty dollars (\$30.00) per one thousand (1,000)
- 35 <u>records shall be charged for electronic records.</u>
- 36 (c) The commissioner may destroy any records of the office $\frac{\text{which}}{\text{that}}$

1	have been maintained on file for five (5) years $\frac{\text{which}}{\text{that}}$ he or she $\frac{\text{may deem}}{\text{deem}}$		
2	considers obsolete and of no further service in carrying out the powers and		
3	duties of the office.		
4	(d) All fees collected under this section shall be deposited to the		
5	State Central Services Fund for the benefit of the Revenue Division of the		
6	Department of Finance and Administration.
