21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 27-24-1418 is repealed.

24 ~~27-24-1418. Pancreatic Cancer Awareness.~~

25 ~~(a) The Director of the Department of Finance and Administration shall~~
26 ~~issue a special license plate for Pancreatic Cancer Awareness in the manner~~
27 ~~and subject to the conditions provided for under this subchapter.~~

28 ~~(b) The special Pancreatic Cancer Awareness motor vehicle license~~
29 ~~plate shall be:~~

30 ~~(1)(A) Designed by pancreatic cancer advocates in the state.~~

31 ~~(B) The design shall be submitted for design approval by~~
32 ~~the director under rules promulgated by the director; and~~

33 ~~(2) Numbered consecutively.~~

34 ~~(c) The procedures concerning costs for issuance under § 27-24-~~
35 ~~1404(c)(1)(A) shall apply.~~

36 ~~(d) The Department of Finance and Administration shall issue a special~~

4 ~~(2)(A) Twenty five dollars (\$25.00) to cover the design use~~
5 ~~contribution.~~

6 ~~(B) The design use contribution shall be remitted monthly~~
7 ~~to the Pancreatic Cancer Action Network; and~~

8 ~~(3)(A) A handling and administrative fee of ten dollars~~
9 ~~(\$10.00).~~

10 ~~(B) The handling and administrative fee shall be:~~

11 ~~(i) Deposited into the State Central Services Fund~~
12 ~~for the benefit of the Revenue Division of the Department of Finance and~~
13 ~~Administration; and~~

14 ~~(ii) Credited to the division as supplemental and in~~
15 ~~addition to all other funds that may be deposited for the benefit of the~~
16 ~~division.~~

17 ~~(C) The handling and administrative fee shall not be~~
18 ~~considered or credited to the division as direct revenue.~~

19 ~~(c)(1) A special license plate issued under this section may be~~
20 ~~renewed annually or replaced under the procedures set out in § 27-24-1405.~~

21 ~~(2) However, the division shall remit the fees collected under §~~
22 ~~27-24-1405(b)(2) on a monthly basis to the fund.~~

24 SECTION 2. Arkansas Code Title 27, Chapter 24, Subchapter 14 is
25 amended to add an additional section to read as follows:

26 27-24-1423. Hospice and palliative care special license plate.

27 (a) The Director of the Department of Finance and Administration shall
28 issue a special motor vehicle license plate for support of hospice and
29 palliative care subject to the conditions provided for under this subchapter.

30 (b) The special hospice and palliative care motor vehicle license
31 plate shall be:

32 (1)(A) Designed by the Hospice and Palliative Care Association
33 of Arkansas.

34 (B) The design shall be submitted for design approval by
35 the director under rules promulgated by the director; and

36 (2)(A) Except as provided under subdivision (b)(2)(B) of this

1 section, numbered consecutively.

2 (B) The Department of Finance and Administration may issue
3 a personalized special license plate for support of hospice and palliative
4 care to a person making a request.

5 (c) The procedures concerning costs for issuance under § 27-24-
6 1404(c)(1)(A) shall apply.

7 (d) The department shall issue a special license plate under this
8 section upon payment of:

9 (1) The fee required by law for registration of the motor
10 vehicle;

11 (2)(A) Twenty-five dollars (\$25.00) to cover the design-use
12 contribution.

13 (B) The design-use contribution shall be remitted monthly
14 to the Hospice and Palliative Care Association of Arkansas; and

15 (3)(A) A handling and administrative fee of ten dollars
16 (\$10.00).

17 (B) The handling and administrative fee shall be:

18 (i) Deposited into the State Central Services Fund
19 for the benefit of the Revenue Division of the Department of Finance and
20 Administration; and

21 (ii) Credited to the division as supplemental and in
22 addition to all other funds that may be deposited for the benefit of the
23 division.

24 (C) The handling and administrative fee shall not be
25 considered or credited to the division as direct revenue.

26 (e)(1) A special license plate issued under this section may be
27 renewed annually or replaced under the procedures set out in § 27-24-1405.

28 (2) However, the division shall remit the fees collected under §
29 27-24-1405(b)(2) on a monthly basis as set forth in subdivision (d)(2)(B) of
30 this section.
