10	SECTION 2. Arkansas Code Title 6, Chapter 13, Subchapter 1, is amended to

12	6-13-113. Participation in certain organizations.		
13	(a) As used in this section "manpower sports" means a sport with		
14	significant person-to-person contact that may increase an athlete's exposure		
15	to head injury, including without limitation football.		
16	(b) Beginning in the 2016-2017 school year, a school district shall		
17	not participate in an organization that governs extra-curricular activities,		
18	including athletics, if the organization distinguishes between public schools		
19	and private schools for the purpose of counting students or classifying		
20	schools for athletic conference play in manpower sports.		
21	(c) A public school or private school that voluntarily chooses move up		
22	a classification level does not violate this section
