20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 *SECTION 1. Arkansas Code § 6-5-1002(b), concerning career and*  
23 *technical education program of study, is amended to read as follows:*

24 *(b)(1) ~~All public school students shall be provided a~~ A rigorous career*  
25 *and technical education program of study that links secondary education and*  
26 *postsecondary education and combines academic and technical education in a*  
27 *structured sequence of courses that progresses from broad foundation skills*  
28 *to occupationally specific courses shall be made available.*

29 *(2) ~~A student may earn postsecondary~~ Post-secondary credits for*  
30 *career and technical education program of study courses that lead to a*  
31 *postsecondary credential, certificate, or degree may be awarded.*

33 *SECTION 2. Arkansas Code § 6-5-1003(b)(3), concerning college and*  
34 *career readiness program standards, is amended to read as follows:*

35 *(3) ~~Sustained, intensive, and focused professional~~ Professional*  
36 *development opportunities for administrators, and teachers, ~~and faculty~~ who*



1 *foster career and technical education programs of study, including design,*  
2 *implementation, and maintenance;*

4 *SECTION 3. Arkansas Code § 6-5-1003(b)(6)(B), concerning college and*  
5 *career readiness program standards, is amended to read as follows:*

6 *(B) The Department of Career Education, in collaboration*  
7 *with the Department of Education and the Department of Higher Education,*  
8 *~~shall work with the Department of Education and the Department of Higher~~*  
9 *~~Education to~~ establish a common course numbering system that incorporates*  
10 *career and technical education program of study courses at both the secondary*  
11 *and postsecondary level;*

13 *SECTION 4. Arkansas Code § 6-5-1003(b)(8)(A), concerning college and*  
14 *career readiness program standards, is amended to read as follows:*

15 *(8) Comprehensive guidance counseling and academic advisory*  
16 *systems developed by the Department of Career Education in collaboration with*  
17 *the Department of Education and the Department of Higher Education that:*

18 *(A) Enable students to make informed decisions about which*  
19 *program of study to pursue;*
