The 3 quarterly report shall be filed no later than fifteen (15) days after the end 4 of each quarter; 5 (B) Beginning with the month of January in the November 6 preceding a calendar year in which a candidate may be listed on any ballot 7 for election, a monthly report of all contributions received and expenditures 8 made during that month. However, for any month in which certain days of that 9 month are included in a preelection report required under subdivision 10 (a)(1)(C) of this section or a final report required under subdivision 11 (a)(1)(D) of this section, no monthly report for that month shall be due. In 12 the case of a primary or runoff election, those days of the month occurring after the date of the election shall be carried forward and included in the 13 14 next monthly report. The monthly report shall be filed no later than fifteen 15 (15) days after the end of each month, except that the final report, covering 16 the month during which an election is held, shall be filed within thirty (30) 17 days after the end of the month in which the last election is held at which 18 the candidate seeks nomination and after the end of the month in which the 19 general election is held. With respect to a special election, the candidate 20 shall file monthly reports under this section beginning with the month in 21 which the special election candidate's total campaign contributions or 22 expenditures exceed five hundred dollars (\$500); 23 24 SECTION 2. Arkansas Code § 7-6-207, concerning reports of 25 contributions for candidates for office other than school district, township, municipal, or county office and resulting from Initiated Act 1 of 1990 and 26 27 Initiated Act 1 of 1996, is amended to add an additional subdivision to read 28 as follows: 29 (e) Reports by Candidates Who Have Filed For Elective Office. 30 (1) If a candidate files for office during the party filing period, for the quarter including the party filing period, the candidate 31 32 shall: 33 (A) File monthly reports under subdivision (a)(1)(B) of this
