16 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 18 LEGISLATIVE INSTITUTE. Members of the preceding General Assembly and the 19 newly elected members of the House of Representatives and Senate shall be 20 eligible to attend the biennial Institute of Legislative Procedure and shall 21 be entitled, upon filing claim therefor, to per diem in the amount fixed by 22 law for members of the General Assembly to receive for attendance at 23 Legislative sessions, for each day in attending the biennial Institute of 24 Legislative Procedure plus mileage for traveling from their place of 25 residence to the biennial Institute of Legislative Procedure and return. 26

27 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General 28 Assembly that any funds disbursed under the authority of the appropriations 29 contained in this act shall be in compliance with the stated reasons for 30 which this act was adopted, as evidenced by the Agency Requests, Executive 31 Recommendations and Legislative Recommendations contained in the budget 32 manuals prepared by the Department of Finance and Administration, letters, or 33 summarized oral testimony in the official minutes of the Arkansas Legislative 34 Council or Joint Budget Committee which relate to its passage and adoption. 35

## SECTION 11. EMERGENCY CLAUSE. It is found and determined by the

1	General Assembly, that the Constitution of the State of Arkansas prohibits
2	the appropriation of funds for more than a one (1) year period; that the
3	effectiveness of this Act on July 1, 2016 is essential to the operation of
4	the agency for which the appropriations in this Act are provided, and that in
5	the event of an extension of the legislative session, the delay in the
6	effective date of this Act beyond July 1, 2016 could work irreparable harm
7	upon the proper administration and provision of essential governmental
8	programs. Therefore, an emergency is hereby declared to exist and this Act
9	being necessary for the immediate preservation of the public peace, health
10	and safety shall be in full force and effect from and after July 1, 2016.
