16 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TUITION 18 REIMBURSEMENT. The Board of Trustees of Southern Arkansas University shall 19 be authorized to reimburse tuition, fees, and other educational related 20 expenses of current faculty who seek additional education levels that will 21 benefit the university in meeting accreditation and professional standards. 22 Reimbursement shall be authorized only when the reimbursement request has 23 been documented by the institution to meet critical shortage instructional 24 areas.

The provisions of this section shall be in effect only from July 1, 2015
26 2016 through June 30, 2016 2017.

27

28 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 29 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL The Board of Trustees at Southern Arkansas University may make 30 ALLOWANCES. 31 special allowances available to any coach who coaches more than one sport in 32 an amount not to exceed \$10,000 per fiscal year for any one coach, to be 33 expended from auxiliary income. Further, if the special allowance funds 34 authorized herein are utilized, Southern Arkansas University shall report 35 annually to the Legislative Joint Auditing Committee the exact disposition of 36 those special allowance funds.

The provisions of this section shall be in effect only from July 1, 2015
 2016 through June 30, 2016 2017.

3

4 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 5 authorized by this act shall be limited to the appropriation for such agency 6 and funds made available by law for the support of such appropriations; and 7 the restrictions of the State Procurement Law, the General Accounting and 8 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditures 9 10 Restrictions Act, or their successors, and other fiscal control laws of this 11 State, where applicable, and regulations promulgated by the Department of 12 Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds. 13

15 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General 16 Assembly that any funds disbursed under the authority of the appropriations 17 contained in this act shall be in compliance with the stated reasons for 18 which this act was adopted, as evidenced by the Agency Requests, Executive 19 Recommendations and Legislative Recommendations contained in the budget 20 manuals prepared by the Department of Finance and Administration, letters, or 21 summarized oral testimony in the official minutes of the Arkansas Legislative 22 Council or Joint Budget Committee which relate to its passage and adoption. 23

24 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the 25 General Assembly, that the Constitution of the State of Arkansas prohibits 26 the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2016 is essential to the operation of 27 the agency for which the appropriations in this Act are provided, and that in 28 the event of an extension of the legislative session, the delay in the 29 30 effective date of this Act beyond July 1, 2016 could work irreparable harm upon the proper administration and provision of essential governmental 31 32 programs. Therefore, an emergency is hereby declared to exist and this Act 33 being necessary for the immediate preservation of the public peace, health 34 and safety shall be in full force and effect from and after July 1, 2016. 35
