23 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MATCHING 24 25 FUNDS. The funds appropriated in this Act for Department of Justice Non-26 Victim Assistance Matching Grants shall be used for matching funds for 27 administering the Federal Grants provided in this Act for the Department of 28 Justice Non-Victim Assistance Grants. The Department of Finance and 29 Administration - Management Services Division is hereby authorized to call 30 upon all state agencies to assist in the implementation of the Department of 31 Justice Non-Victim Assistance Grants. SECTION 24. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

1	Procedures and Restrictions Act, or their successors, and other fiscal	
2	control laws of this State, where applicable, and regulations promulgated by	
3	the Department of Finance and Administration, as authorized by law, shall be	
4	strictly complied with in disbursement of said funds.

6	SECTION 25. LEGISLATIVE INTENT. It is the intent of the General	
7	Assembly that any funds disbursed under the authority of the appropriations	
8	contained in this act shall be in compliance with the stated reasons for	
9	which this act was adopted, as evidenced by the Agency Requests, Executive	
10	Recommendations and Legislative Recommendations contained in the budget
