17 SECTION 3. EMPLOYMENT OF ATTORNEYS. None of the funds appropriated in 18 this Act for Maintenance and General Operation shall be expended in payment 19 for services of attorneys, unless the agency shall first make a request in 20 writing to the Attorney General of the State of Arkansas to provide the 21 required legal services. The Attorney General's Office shall provide the 22 requested legal services, or, if the Attorney General's Office shall 23 determine that sufficient personnel are not available to provide the 24 requested legal services, the Attorney General shall certify the same to the 25 agency and may authorize the agency to employ legal counsel and to expend 26 monies appropriated for Maintenance and General Operations therefor, if:

27 (1) The Attorney General determines, and certifies in writing, that28 such agency needs the advice or assistance of legal counsel, and

29 (2) The Attorney General consents in writing to the employment of the30 legal counsel to be retained by the agency.

31 Such certification shall be required with respect to each instance of 32 the employment of special legal counsel, or shall be required annually with 33 respect to legal counsel employed on a retainer basis. A copy of such 34 certification shall be entered in the official minutes of the agency, and 35 shall be retained in the fiscal records of the agency for audit purposes. 36

1 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 2 authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and 3 4 the restrictions of the State Procurement Law, the General Accounting and 5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 6 Procedures and Restrictions Act, or their successors, and other fiscal 7 control laws of this State, where applicable, and regulations promulgated by 8 the Department of Finance and Administration, as authorized by law, shall be 9 strictly complied with in disbursement of said funds.

11 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General 12 Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for 13 14 which this act was adopted, as evidenced by the Agency Requests, Executive 15 Recommendations and Legislative Recommendations contained in the budget 16 manuals prepared by the Department of Finance and Administration, letters, or 17 summarized oral testimony in the official minutes of the Arkansas Legislative 18 Council or Joint Budget Committee which relate to its passage and adoption. 19

20 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the 21 22 appropriation of funds for more than a one (1) year period; that the 23 effectiveness of this Act on July 1, 2016 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in 24 25 the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2016 could work irreparable harm 26 27 upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act 28 29 being necessary for the immediate preservation of the public peace, health 30 and safety shall be in full force and effect from and after July 1, 2016. 31 32 33 34 35
