20	SECTION 1. REAPP	PROPRIATION - GENERAL IMPROVEMENT I	FUNDS. There is
21	hereby appropriated, t	to the War Memorial Stadium Commiss	sion, to be payable

8	SECTION 2. REAPPROPRIATION - CASH FUNDS. There is hereby appropriated,		
9	to the War Memorial Stadium Commission, to be payable from the cash funds as		
10	defined by Arkansas Code 19-4-801, for the War Memorial Stadium Commission		
11	the following:		
12	(A) Effective July 1, 2016, the balance of the appropriation provided		
13	in Item (A) Section 2 of Act 185 of 2015, for maintenance and replacement of		
14	Field Turf of War Memorial Stadium, in a sum not to exceed\$435,000.		
15	(B) Effective July 1, 2016, the balance of the appropriation provided		
16	in Item (B) Section 2 of Act 185 of 2015, for maintenance, renovation,		
17	equipping, construction, acquisition, improvement, upgrade and repair of the		
18	Southwest Concourse Restrooms of War Memorial Stadium, in a sum not to exceed		
19	\$42,500.		
20	(C) Effective July 1, 2016, the balance of the appropriation provided		
21	in Item (C) Section 2 of Act 185 of 2015, for replacement, maintenance,		
22	renovation, equipping, construction, acquisition, and improvement of the		
23	North and South Scoreboards of the War Memorial Stadium, in a sum not to		
24	exceed\$127,500.		
25	(D) Effective July 1, 2016, the balance of the appropriation provided		
26	in Item (A) Section 1 of Act 135 of 2015, for various maintenance,		
27	renovation, equipping, construction, acquisition, improvement, upgrade, and		
28	repair of real property and facilities, in a sum not to exceed\$6,771.		
29			
30	SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor		
31	obligations otherwise incurred in relation to the project or projects		
32	described herein in excess of the State Treasury funds actually available		
33	therefor as provided by law. Provided, however, that institutions and		
34	agencies listed herein shall have the authority to accept and use grants and		
35	donations including Federal funds, and to use its unobligated cash income or		
36	funds, or both available to it, for the purpose of supplementing the State		

- 1 Treasury funds for financing the entire costs of the project or projects
- 2 enumerated herein. Provided further, that the appropriations and funds
- 3 otherwise provided by the General Assembly for Maintenance and General
- 4 Operations of the agency or institutions receiving appropriation herein shall
- 5 not be used for any of the purposes as appropriated in this act.
- 6 (B) The restrictions of any applicable provisions of the State
- 7 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
- 8 Revenue Stabilization Law and any other applicable fiscal control laws of
- 9 this State and regulations promulgated by the Department of Finance and
- 10 Administration, as authorized by law, shall be strictly complied with in
- ll disbursement of any funds provided by this act unless specifically provided
- 12 otherwise by law.

- 14 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
- 15 Assembly that any funds disbursed under the authority of the appropriations
- 16 contained in this act shall be in compliance with the stated reasons for
- 17 which this act was adopted, as evidenced by the Agency Requests, Executive
- 18 Recommendations and Legislative Recommendations contained in the budget
- 19 manuals prepared by the Department of Finance and Administration, letters, or
- 20 summarized oral testimony in the official minutes of the Arkansas Legislative
- 21 Council or Joint Budget Committee which relate to its passage and adoption.

- 23 <u>SECTION 5. EMERGENCY CLAUSE.</u> It is found and determined by the General
- 24 Assembly, that the Constitution of the State of Arkansas prohibits the
- 25 appropriation of funds for more than a one (1) year period; that the
- 26 <u>effectiveness of this Act on July 1, 2016 is essential to the operation of</u>
- 27 the agency for which the appropriations in this Act are provided, and that in
- 28 the event of an extension of the legislative session, the delay in the
- 29 effective date of this Act beyond July 1, 2016 could work irreparable harm
- 30 upon the proper administration and provision of essential governmental
- 31 programs. Therefore, an emergency is hereby declared to exist and this Act
- 32 being necessary for the immediate preservation of the public peace, health
- 33 and safety shall be in full force and effect from and after July 1, 2016.
