12 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 13 14 OF FUNDS FOR THE JUVENILE OMBUDSMAN PROGRAM. 26 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 28 OF FUNDS FOR LOCAL JUVENILE DETENTION FACILITIES. The Chief Fiscal Officer 29 of the State shall transfer funds in an amount of \$400,000 for the fiscal year ending June 30, 2016 2017 from the Department of Human Services - Youth 30 31 Services Fund Account to the Juvenile Detention Facilities Operating Fund to 32 fund the appropriation to the Department of Finance and Administration -33 Disbursing Officer for grants for operating expenses of local juvenile 34 detention facilities.

7 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. YOUTH 9 SERVICES - TIMBER SALES PROCEEDS - CAPITAL IMPROVEMENTS AND EQUIPMENT. 10 Division of Youth Services is authorized to use the administrative operating 11 account for capital improvements to the physical plant and for the purchase 12 of capital equipment by the Mansfield Youth Services Facility operated by the 13 Department of Human Services, Division of Youth Services. The funds shall be 14 held by the Department of Human Services, Division of Youth Services from the 15 proceeds of the sale of timber that may be harvested from land owned by the 16 Division of Youth Services. All funds deposited and all expenses shall be 17 tracked separately. The harvesting of timber is specifically authorized to 18 provide funds to finance capital improvements to the physical plant and for 19 the purchase of major capital equipment by the Mansfield Facility from which 20 the timber is sold.

The Division of Youth Services shall report all income derived from the sale of timber to the Chief Fiscal Officer of the State and the Arkansas Legislative Council. Any contracts initiated for the harvesting and sale of timber shall be submitted to the Review Subcommittee of the Arkansas Legislative Council for prior review. All expenditures of funds derived from the sale of timber will be expended in accordance with relevant state purchasing laws.

SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REGULAR SALARIES - CONTINGENT EDUCATIONAL SERVICES POSITIONS. If it has been determined by the Director of the Department of Human Services that the Division of Youth Services cannot continue a contract with a private provider for educational services and deems it necessary to utilize Division staff to

1 SECTION 13. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 2 authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and 3 4 the restrictions of the State Procurement Law, the General Accounting and 5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 6 Procedures and Restrictions Act, or their successors, and other fiscal 7 control laws of this State, where applicable, and regulations promulgated by 8 the Department of Finance and Administration, as authorized by law, shall be 9 strictly complied with in disbursement of said funds.

10

11 SECTION 14. LEGISLATIVE INTENT. It is the intent of the General 12 Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for 13 14 which this act was adopted, as evidenced by the Agency Requests, Executive 15 Recommendations and Legislative Recommendations contained in the budget 16 manuals prepared by the Department of Finance and Administration, letters, or 17 summarized oral testimony in the official minutes of the Arkansas Legislative 18 Council or Joint Budget Committee which relate to its passage and adoption. 19

20 SECTION 15. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits 21 22 the appropriation of funds for more than a one (1) year period; that the 23 effectiveness of this Act on July 1, 2016 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in 24 25 the event of an extension of the legislative session, the delay in the 26 effective date of this Act beyond July 1, 2016 could work irreparable harm 27 upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act 28 29 being necessary for the immediate preservation of the public peace, health 30 and safety shall be in full force and effect from and after July 1, 2016. 31 32 33 34 35
