20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 Officer, to be payable from the General Improvement Fund or its successor

7 Relief Alliance to support hunger relief efforts throughout the state, in a  
8 sum not to exceed.....\$15,000.

9  
10 SECTION 6. REAPPROPRIATION - GENERAL IMPROVEMENT PLANNING AND  
11 DEVELOPMENT WORK COLLEGE GRANTS. There is hereby appropriated, to the  
12 Department of Finance and Administration - Disbursing Officer, to be payable  
13 from the General Improvement Fund or its successor fund or fund accounts, for  
14 Work College grants to planning and development districts, the following:

15 (A) Effective July 1, 2016, the balance of the appropriation provided  
16 in Item (A) Section 1 of Act 417 of 2015, for the Northwest Arkansas Economic  
17 Development District, Inc. for grants to work colleges, as defined by U.S.C.,  
18 Title 42, Section 2756b, that is part of the Work Colleges Consortium, for  
19 personal services and operating expenses, scholarships, research, development  
20 and delivery of education coursework and math and science coursework, costs  
21 associated with athletic programs, land acquisition, equipment acquisition,  
22 infrastructure costs, including site development costs, construction,  
23 improvements, landscaping, renovation, dorm renovation, major maintenance,  
24 building of roads and/or parking *lots or personal services and operating*  
25 *expenses, improvements, construction, renovation, major maintenance, purchase*  
26 *of equipment, or building or repairing parking lots for the Northwest*  
27 *Arkansas Economic Development District, Inc.,* in a sum not to  
28 exceed.....\$33,000.

29  
30 SECTION 7. REAPPROPRIATION - LITTLE ROCK ZOO IMPROVEMENTS GRANT. There  
31 is hereby appropriated, to the Department of Finance and Administration -  
32 Disbursing Officer, to be payable from the General Improvement Fund or its  
33 successor fund or fund accounts, the following:

34 (A) Effective July 1, 2016, the balance of the appropriation provided  
35 in Item (A) Section 1 of Act 427 of 2015, for a grant for improvements to the  
36 education building, an Arkansas Farm Exhibit, general grounds maintenance,

1 equipment, construction, renovation and operating expenses for the Little  
2 Rock Zoo, in a sum not to exceed.....\$60,000.

3  
4 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As  
6 referenced in Section 1 (A) of Act 417 of 2015, and Section 3(c) of Act 1147  
7 of 2015, the authorized funding for the Northwest Arkansas Economic  
8 Development District, Inc. for grants to work colleges, as defined by U.S.C.,  
9 Title 42, Section 2756b, that is part of the Work Colleges Consortium, for  
10 personal services and operating expenses, scholarships, research, development  
11 and delivery of education coursework and math and science coursework, costs  
12 associated with athletic programs, land acquisition, equipment acquisition,  
13 infrastructure costs, including site development costs, construction,  
14 improvements, landscaping, renovation, dorm renovation, major maintenance,  
15 building of roads and/or parking lots, shall be deemed to also include  
16 personal services and operating expenses, improvements, construction,  
17 renovation, major maintenance, purchase of equipment, or building or  
18 repairing parking lots for the Northwest Arkansas Economic Development  
19 District, Inc."

20  
21 SECTION 9. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
22 obligations otherwise incurred in relation to the project or projects  
23 described herein in excess of the State Treasury funds actually available  
24 therefor as provided by law. Provided, however, that institutions and  
25 agencies listed herein shall have the authority to accept and use grants and  
26 donations including Federal funds, and to use its unobligated cash income or  
27 funds, or both available to it, for the purpose of supplementing the State  
28 Treasury funds for financing the entire costs of the project or projects  
29 enumerated herein. Provided further, that the appropriations and funds  
30 otherwise provided by the General Assembly for Maintenance and General  
31 Operations of the agency or institutions receiving appropriation herein shall  
32 not be used for any of the purposes as appropriated in this act.

33 (B) The restrictions of any applicable provisions of the State  
34 Purchasing Law, the General Accounting and Budgetary Procedures Law, the  
35 Revenue Stabilization Law and any other applicable fiscal control laws of  
36 this State and regulations promulgated by the Department of Finance and



1 Administration, as authorized by law, shall be strictly complied with in  
2 disbursement of any funds provided by this act unless specifically provided  
3 otherwise by law.

4  
5 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General  
6 Assembly that any funds disbursed under the authority of the appropriations  
7 contained in this act shall be in compliance with the stated reasons for  
8 which this act was adopted, as evidenced by the Agency Requests, Executive  
9 Recommendations and Legislative Recommendations contained in the budget  
10 manuals prepared by the Department of Finance and Administration, letters, or  
11 summarized oral testimony in the official minutes of the Arkansas Legislative  
12 Council or Joint Budget Committee which relate to its passage and adoption.

13  
14 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the  
15 General Assembly, that the Constitution of the State of Arkansas prohibits  
16 the appropriation of funds for more than a one (1) year period; that the  
17 effectiveness of this Act on July 1, 2016 is essential to the operation of  
18 the agency for which the appropriations in this Act are provided, and that in  
19 the event of an extension of the legislative session, the delay in the  
20 effective date of this Act beyond July 1, 2016 could work irreparable harm  
21 upon the proper administration and provision of essential governmental  
22 programs. Therefore, an emergency is hereby declared to exist and this Act  
23 being necessary for the immediate preservation of the public peace, health  
24 and safety shall be in full force and effect from and after July 1, 2016.
