19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 6-1-404(a), concerning the membership of
22 the School Leadership Coordinating Council, is amended to read as follows:

23 (a) The School Leadership Coordinating Council consists of ~~thirteen~~
24 ~~(13)~~ fifteen (15) members as follows:

25 (1) The Chair of the Arkansas Association of Colleges for
26 Teacher Education Council of Deans;

27 (2) The Commissioner of Education;

28 (3) The Director of the Arkansas Leadership Academy;

29 (4) The Director of the Department of Higher Education;

30 (5) The Director of the Department of Career Education;

31 (6) The Executive Director of the Arkansas Association of
32 Educational Administrators;

33 (7) The Executive Director of the Arkansas Education
34 Association;

35 (8) The Executive Director of the Arkansas School Boards
36 Association;



1 (9) The Executive Director of the Arkansas Association for
2 Supervision and Curriculum Development;

3 (10) ~~The President~~ Executive Director of the Arkansas Rural
4 Education Association;

5 (11) A representative from the Arkansas Professors of
6 Educational Administration;

7 (12) A representative from the Arkansas Center for Executive
8 Leadership; ~~and~~

9 (13) A representative from an education service cooperative;

10 (14) A representative from the Arkansas Public School Resource
11 Center;

12 (15) The Chair of the Senate Committee on Education or the
13 chair's designee; and

14 (16) The Chair of the House Committee on Education or the
15 chair's designee.

17 SECTION 2. Arkansas Code § 6-1-404(f), concerning expenses incurred
18 from serving on the School Leadership Coordinating Council, is amended to
19 read as follows:

20 (f)(1) All nonlegislative members of the council may receive expense
21 reimbursement in accordance with § 25-16-902 paid by the Department of
22 Education if funds are available.

23 (2) Legislative members of the council shall be paid per diem
24 and mileage as authorized by law for attendance at meetings of interim
25 committees of the General Assembly.
