## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE STATE DEPARTMENT FOR  
10 SOCIAL SECURITY ADMINISTRATION DISABILITY  
11 DETERMINATION FOR THE FISCAL YEAR ENDING JUNE 30,  
12 2018; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE STATE DEPARTMENT FOR  
16 SOCIAL SECURITY ADMINISTRATION DISABILITY  
17 DETERMINATION APPROPRIATION FOR THE 2017-  
18 2018 FISCAL YEAR.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the State  
25 Department for Social Security Administration Disability Determination for  
26 the 2017-2018 fiscal year, the following maximum number of regular employees.

35 SECTION 2. EXTRA HELP. There is hereby authorized, for the State  
 36 Department for Social Security Administration Disability Determination for

1 the 2017-2018 fiscal year, the following maximum number of part-time or  
 2 temporary employees, to be known as "Extra Help", payable from funds  
 3 appropriated herein for such purposes: twenty (20) temporary or part-time  
 4 employees, when needed, at rates of pay not to exceed those provided in the  
 5 Uniform Classification and Compensation Act, or its successor, or this act  
 6 for the appropriate classification.

7  
 8 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 9 to the State Department for Social Security Administration Disability  
 10 Determination, to be payable from the federal funds as designated by the  
 11 Chief Fiscal Officer of the State, for personal services and operating  
 12 expenses of the State Department for Social Security Administration  
 13 Disability Determination for the fiscal year ending June 30, 2018, the  
 14 following:

 30 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA  
 32 HELP RESTRICTION. No extra help employee of Disability Determination for  
 33 Social Security Administration shall be employed for a period of time to  
 34 exceed eighteen hundred (1800) hours in any single fiscal year.

35 The provisions of this section shall be in effect only from July 1, ~~2016~~  
 36 2017 through June 30, ~~2017~~ 2018.

2 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
3 authorized by this act shall be limited to the appropriation for such agency  
4 and funds made available by law for the support of such appropriations; and  
5 the restrictions of the State Procurement Law, the General Accounting and  
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
7 Procedures and Restrictions Act, or their successors, and other fiscal  
8 control laws of this State, where applicable, and regulations promulgated by  
9 the Department of Finance and Administration, as authorized by law, shall be  
10 strictly complied with in disbursement of said funds.  
11

12 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General  
13 Assembly that any funds disbursed under the authority of the appropriations  
14 contained in this act shall be in compliance with the stated reasons for  
15 which this act was adopted, as evidenced by the Agency Requests, Executive  
16 Recommendations and Legislative Recommendations contained in the budget  
17 manuals prepared by the Department of Finance and Administration, letters, or  
18 summarized oral testimony in the official minutes of the Arkansas Legislative  
19 Council or Joint Budget Committee which relate to its passage and adoption.  
20

21 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General  
22 Assembly, that the Constitution of the State of Arkansas prohibits the  
23 appropriation of funds for more than a one (1) year period; that the  
24 effectiveness of this Act on July 1, 2017 is essential to the operation of  
25 the agency for which the appropriations in this Act are provided, and that in  
26 the event of an extension of the legislative session, the delay in the  
27 effective date of this Act beyond July 1, 2017 could work irreparable harm  
28 upon the proper administration and provision of essential governmental  
29 programs. Therefore, an emergency is hereby declared to exist and this Act  
30 being necessary for the immediate preservation of the public peace, health  
31 and safety shall be in full force and effect from and after July 1, 2017.
