31	(a) The purpose of	this section is to honor the	e family members of a

33	(b) The Department	of Finance and Administration	<del>on is authorized to</del>

9	(c) There is no cost for the issuance or renewal of the Gold Star		
10	Family special license plate under this section.		
11	(d)(1) The Department of Finance and Administration shall design the		
12	special license plates issued under this section as provided under this		
13	subsection.		
14	(2) The design of the Gold Star Family special license plate		
15	shall include a large gold star on the left-hand side of the special license		
16	plate and a decal at the bottom of the plate that states "Gold Star Family"		
17	in lieu of the legend "The Natural State" or any succeeding legend.		
18	(e) A Gold Star Family special license plate is not transferable as		
19	provided under § 27-24-207.		
20	(f) The registration of a special license plate under this section may		
21	continue from year to year so long as it is renewed each year within the time		
22	and manner required by law.		
23	(g) A family member applying for a Gold Star Family special license		
24	plate authorized by subsection (b) of this section shall provide the		
25	Department of Finance and Administration with:		
26	(1) Evidence of the receipt of a Gold Star lapel button issued		
27	by the United States Department of Defense under 10 U.S.C. § 1126; or		
28	(2) A copy of the final Leave and Earnings Statement issued to		
29	the deceased service member showing that he or she was entitled to:		
30	(A) Hardship duty pay;		
31	(B) Hostile fire pay; or		
32	(C) Imminent danger pay.		
33	(h) As used in this section:		
34	(1) "Deceased service member" means a member of the United		
35	States Armed Forces who died while serving in:		
36	(A) An area of conflict recognized by the United States		

1	Department of Defense; or		
2	(B) A location that entitles the deceased service member		
3	to:		
4	(i) Hardship duty pay;		
5	(ii) Hostile fire pay; or		
6	(iii) Imminent danger pay; and		
7	(2) "Family member" means a spouse, parent, sibling, or child of		
8	a member of the United States Armed Forces.
