21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code § 27-24-211 is amended to read as follows:	
24	27-24-211. Gold Star Family special license plates <u>- Definitions</u> .	
25	(a) The purpose of this section is to honor:	
26	(1) The spouse of a member of the United States Armed Forces	
27	whose spouse has been killed in a conflict recognized by the Department of	
28	Defense; and	
29	(2) The parent of a member of the United States Armed Forces	
30	whose child has been killed in a conflict recognized by the Department of	
31 32	Defense.	
32 33	(a) The purpose of this section is to honor the family members of a deceased service member.	
33 34	(b) The Department of Finance and Administration is authorized to	
35	issue one (1) Cold Star Family special license plate to an applicant who	
36	establishes upon initial application that he or she:

1	(1) Is the spouse or parent of a member of the United States
2	Armed Forces who has been killed in a conflict recognized by the Department
3	of Defense; and
4	(2) Has received a Gold Star Lapel Button issued by the
5	Department of Defense under 10 U.S.C. § 1126.
6	(b) The Department of Finance and Administration is authorized to
7	issue one (1) Gold Star Family special license plate to an applicant who
8	establishes upon initial application that he or she is a family member of a
9	deceased service member.
10	(c) There is no cost for the issuance or renewal of the Gold Star
11	Family special license plate under this section.
12	(d)(l) The Department of Finance and Administration shall design the
13	special license plates issued under this section as provided under this
14	subsection.
15	(2) The design of the Gold Star Family special license plate
16	shall include a large gold star on the left-hand side of the special license
17	plate and a decal at the bottom of the plate that states "Gold Star Family"
18	in lieu of the legend "The Natural State" or any succeeding legend.
19	(e) A Gold Star Family special license plate is not transferable as
20	provided under § 27-24-207.
21	(f) The registration of a special license plate under this section may
22	continue from year to year so long as it is renewed each year within the time
23	and manner required by law.
24	(g) A family member applying for a Gold Star Family special license
25	plate authorized by subsection (b) of this section shall provide the
26	Department of Finance and Administration with:
27	(1) Evidence of the receipt of a Gold Star lapel button issued

29	(2) A copy of the final Leave and Earnings Statement issued to
