24	SECTION 1. Ark	cansas Code Title 7, Chapter 5, Subchap	ter 2, is amended
25	to add an additional	section to read as follows:	
26	7-5-213. Notic	ce of special election.	
27	(a)(l) Except	as provided under subdivision (a)(2) o	f this section,
28	the county clerk shal	ll mail notice of a special election to	the registered
29	voters in the county	who are eligible to vote in the specia	l election no less
30	than fifteen (15) day	vs before the date of the special elect	ion and no more
31	than thirty (30) days	s before the date of the special electi	on.
32	<u>(2) Noti</u>	ce under this section is not required	if the special
33	election is:		
34	<u>(A)</u>	To fill a vacancy; or	
35	<u>(B)</u>	Called by petition.	
36	(b) The notice	e shall state:	

1	(1) The date of the special election;		
2	(2) The hours of voting on the special election day;		
3	(3) If early voting locations will be opened, the places and		
4	times for early voting;		
5	(4) The locations of polling sites for holding the special		
6	election in the county; and		
7	(5) The candidates and offices to be elected at that time, if		
8	any.		
9	(c) In addition to the notice in subdivision (a)(1) of this section,		
10	the county clerk shall post and make available the following information on		
11	the official website of the county clerk:		
12	(1) The full text of all measures on the ballot, if any;		
13	(2) The time and location of the opening, processing,		
14	canvassing, and counting of ballots;		
15	(3) A sample ballot;		
16	(4) Instructions on how to vote;		
17	(5) General information on voting rights under applicable		
18	federal and state laws, including information on the right of an individual		
19	to cast a provisional ballot and instructions on how to contact the		
20	appropriate officials if any of these rights are alleged to have been		
21	violated; and		
22	(6) General information on federal and state laws regarding		
23	prohibitions on acts of fraud and misrepresentation.		
24	(d) Expenses of the notice of special elections under this section		
25	shall be paid by the entity that sponsors the special election.

29	In addition to the publication of the calling document, notice of		
30	special elections under this chapter shall be published and posted under §§
