22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 12-12-317 is amended to read as follows:
25 12-12-317. Death certificates.

26 (a) The Except as provided under subsection (b) of this section, the
27 certificate of death of ~~any a~~ a person whose death is investigated under ~~the~~
28 ~~provisions of~~ this subchapter shall be made by the State Medical Examiner or
29 by his or her designee or by the county coroner, ~~whoever shall have~~ conducted
30 the investigation.

31 (b) ~~However, where a postmortem examination has been performed, the~~
32 ~~certificate of death shall be made and signed by the examiner or his or her~~
33 ~~associates or assistants, whoever shall have performed the postmortem~~
34 ~~examination~~ The examiner or his or her designee shall make and sign a
35 certificate of death if:

36 (1)(A) The examiner or his or her designee performs a postmortem



1 examination.

2 (B) The person who performs the postmortem examination
 3 shall make and sign the certificate of death; or

4 (2)(A) The certificate of death is for a person executed for a
 5 capital offense.

6 (B) The examiner or his or her designee shall list on the
 7 certificate of death the cause of death for a person executed for a capital
 8 offense as "Pursuant to a judicial sentence of death – Execution".

9 (c) When a petition is filed with a court of competent jurisdiction to
 10 change the cause or manner of death listed on a ~~death~~ certificate of death
 11 which has been signed by the examiner or by his or her designee, the State
 12 Crime Laboratory shall be notified of such petition, and the examiner or his
 13 or her designee shall be allowed to hear testimony presented by the
 14 petitioner and shall be given an opportunity to present evidence to the court
 15 to support the original ruling of the examiner or his or her ~~assistant~~
 16 designee who signed the certificate of death.
