27	SECTION 1. Arkansas Code § 12-12-919(a), concerning lifetime	
28	registration required for certain sex offenders, is amended to read as	
29	follows:	
30	(a) Lifetime registration is required for a sex offender who:	
31	(1) Was found to have committed an aggravated sex offense;	
32	(2) Was determined by the court to be or assessed as a Level 4	
33	sexually dangerous person; <del>or</del>	
34	(3) Has pleaded guilty or nolo contendere to or been found	
35	guilty of a second or subsequent sex offense under a separate case number,	
36	not multiple counts on the same charge <del>.;</del> or

2	103(a)(1), or other substantially similar offense in another jurisdiction.

4	SECTION 2. Arkansas Code § 12-12-919, concerning the termination of an
5	obligation to register as a sex offender, is amended to add an additional
6	subsection to read as follows:
7	(d) A person who was convicted of rape by forcible compulsion, § 5-14-
8	103(a)(1), or another substantially similar offense in another jurisdiction
9	before March 1, 2003, and who was never required to register as a sex
10	offender or who has subsequently been removed from the Arkansas Sex Offender
11	<u>Registry is required to register or reregister as a sex offender under this</u>
12	subchapter within sixty (60) days of the effective date of this act or be
13	subject to arrest and prosecution under § 12-12-904(a).
