In order that exceptionally well-qualified personnel may be recruited and 3 4 retained, the House of Representatives may exceed the maximum salary levels 5 by no more than twenty percent (20%) for no more than one-third (1/3) of the 6 positions authorized in their operation appropriation act, may exceed the 7 maximum salary levels for the purpose of merit adjustments for all positions, 8 and may promote a maximum of two grades for no more than one-third (1/3) of 9 the classified positions authorized in its operation appropriation act. 10 11 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. AUDIO/VISUAL POLICY. The appropriations provided herein to produce audio or 13 14 video materials by or under the direction of the House of Representatives 15 shall not be used for the following: 16 (a) A person may not use audio or video materials produced by or under the 17 direction of the House of Representatives in political or campaign 18 advertising. 19 (b) A person may not use audio or video materials produced by or under the 20 direction of the House of Representatives for a commercial purpose. 21 (1) In this section, "commercial purpose" means a purpose that is 22 intended to result in a profit or other tangible benefit. 23 (c) The House Management Committee may give permission to an entity to use 24 the audio or video materials for public education governmental 25 broadcast which shall not conflict with subsection (b). 26 27 SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 28 authorized by this act shall be limited to the appropriation for such agency 29 and funds made available by law for the support of such appropriations; and 30 the restrictions of the State Procurement Law, the General Accounting and 31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 32 Procedures and Restrictions Act, or their successors, and other fiscal 33 control laws of this State, where applicable, and regulations promulgated by 34 the Department of Finance and Administration, as authorized by law, shall be 35 strictly complied with in disbursement of said funds.

1	SECTION 18. LEGISLATIVE INTENT. It is the intent of the General
2	Assembly that any funds disbursed under the authority of the appropriations
3	contained in this act shall be in compliance with the stated reasons for
4	which this act was adopted, as evidenced by the Agency Requests, Executive
5	Recommendations and Legislative Recommendations contained in the budget
6	manuals prepared by the Department of Finance and Administration, letters, or
7	summarized oral testimony in the official minutes of the Arkansas Legislative
8	Council or Joint Budget Committee which relate to its passage and adoption.
9	
10	SECTION 19. EMERGENCY CLAUSE. It is found and determined by the
11	General Assembly, that the Constitution of the State of Arkansas prohibits
12	the appropriation of funds for more than a one (1) year period; that the
13	effectiveness of this Act on July 1, 2017 is essential to the operation of
14	the agency for which the appropriations in this Act are provided, and that in
15	the event of an extension of the legislative session, the delay in the
16	effective date of this Act beyond July 1, 2017 could work irreparable harm
17	upon the proper administration and provision of essential governmental
18	programs. Therefore, an emergency is hereby declared to exist and this Act
19	being necessary for the immediate preservation of the public peace, health
20	and safety shall be in full force and effect from and after July 1, 2017.
