NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 21 22 EXTRA HELP - DOG RACING. There is hereby authorized, for the Department of 23 Finance and Administration - Division of Racing - Dog Racing, for the 2016-24 2017 2017-2018 fiscal year, the maximum number of thirty-one (31) nine (9) 25 part-time or temporary employees, to be known as "Extra Help", payable from 26 funds appropriated herein for such purposes, such employees shall be 27 authorized to work over 1,000 hours per year. 28 The provisions of this section shall be in effect only from July 1, 2016 29 2017 through June 30, 2017 2018. 30 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 31 32 authorized by this act shall be limited to the appropriation for such agency 33 and funds made available by law for the support of such appropriations; and 34 the restrictions of the State Procurement Law, the General Accounting and

Procedures and Restrictions Act, or their successors, and other fiscal

Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

1	control laws of this State, where applicable, and regulations promulgated by		
2	the Department of Finance and Administration, as authorized by law, shall be		
3	strictly complied with in disbursement of said funds.

5	SECTION 7. LEGISLATIVE INTENT. It is the intent of the General		
6	Assembly that any funds disbursed under the authority of the appropriations		
7	contained in this act shall be in compliance with the stated reasons for		
8	which this act was adopted, as evidenced by the Agency Requests, Executive		
9	Recommendations and Legislative Recommendations contained in the budget		
10	manuals prepared by the Department of Finance and Administration, letters, or		
11	summarized oral testimony in the official minutes of the Arkansas Legislative		
12	Council or Joint Budget Committee which relate to its passage and adoption.		
13			
14	SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General		
15	Assembly, that the Constitution of the State of Arkansas prohibits the		
16	appropriation of funds for more than a one (1) year period; that the		
17	effectiveness of this Act on July 1, 2017 is essential to the operation of		
18	the agency for which the appropriations in this Act are provided, and that in		
19	the event of an extension of the legislative session, the delay in the		
20	effective date of this Act beyond July 1, 2017 could work irreparable harm		
21	upon the proper administration and provision of essential governmental		
22	programs. Therefore, an emergency is hereby declared to exist and this Act		
23	being necessary for the immediate preservation of the public peace, health		
24	and safety shall be in full force and effect from and after July 1, 2017.
