- SECTION 3. Arkansas Code § 14-14-1301(b)(1), concerning quorum court district and township officers, is amended to remove language made obsolete by Arkansas Constitution, Amendment 80, to read as follows:
- 6 (1)(A) There shall be elected in each of the quorum court
 7 districts of the counties of this state one (1) justice of the peace who
 8 shall preside over the justice of the peace courts and perform such judicial
 9 duties as may be prescribed by law and who shall serve as a member of the
 10 quorum court of the county in which elected and shall perform such
 11 legislative duties as may be prescribed by law.
- 12 <u>(B)</u> Each justice shall be a qualified elector and a resident of the district for which he or she is elected.

- SECTION 4. Arkansas Code § 14-37-111(c), concerning the reduction of a city to a lower grade, is amended to remove language made obsolete by Arkansas Constitution, Amendment 80, to read as follows:
 - (c) Whenever a city of the first class is reduced to the grade of a city of the second class or an incorporated town, the mayor of the city shall automatically become the police judge, and the office of police judge shall automatically be abolished. All other officers of a city whose grade may be reduced When the grade of a city has been reduced to city of the second class or to incorporated town, all officers of that city or town shall continue in office until the next general election for the city or town.

- SECTION 5. Arkansas Code § 14-42-109 is amended to remove references to police judges made obsolete by Arkansas Constitution, Amendment 80, to read as follows:
- 29 14-42-109. Removal of elective or appointed officers.
 - (a)(1)(A) If the mayor or police judge, member of the city council, or any other elective officer of any city of the first class or second class or incorporated town in this state shall wilfully and knowingly fail, refuse, or neglect to execute, or cause to be executed, any of the laws or ordinances within their jurisdiction, they shall be deemed guilty of nonfeasance in office.
- 36 (B)(i) It shall be the duty of the circuit court of any

- 1 county within which any officer may be commissioned and acting, upon
- 2 indictment charging any such officer with nonfeasance in office, to hear and
- 3 determine the charges.
- 4 (ii) If, upon hearing, the charges are proved to be
- 5 true, the court shall enter a judgment of record removing the guilty officer
- 6 from office.
- 7 (2) The council of any city or incorporated town may provide, by
- 8 proper ordinance, for the removal of any appointive officer upon a majority
- 9 vote of the council.
- 10 (b)(1) Upon the entering of judgment as provided in subdivision (a)(1)
- 11 of this section, the office of mayor or police judge shall become vacant.
- 12 (2)(A) It shall be the duty of the clerk of the circuit court to
- 13 immediately make out and deliver to the Governor a true and certified copy of
- 14 the judgment.
- 15 (B) Thereupon, it shall be the duty of the Governor to at
- 16 once appoint and commission a mayor or police judge for the city or town to
- 17 fill the vacancy until his or her successor is elected at the next regular
- 18 election and qualified.
- 19 (c) Any mayor or police judge so removed from office shall have the
- 20 right of appeal to the Supreme Court. However, no appeal shall have the
- 21 effect of suspending the judgment of removal of the circuit court. If the
- 22 judgment is reversed, it shall have the effect of reinstating the officer to
- 23 his or her office.

- 25 SECTION 6. Arkansas Code § 14-42-113(b)(4), concerning salaries of
- 26 officials, is amended to clarify the wording subsequent to the 2013 amendment
- 27 of subdivision (b)(4)(A), to read as follows:
- 28 (4)(A) Upon restoration of his or her professional license or
- 29 registration, an elected official of a city of the first class, a city of the
- 30 second class, or an incorporated town may petition the governing body of the
- 31 city or town for a resumption of salary, and the governing body shall
- 32 initiate measures to ensure that the elected official's salary is resumed.
- 33 (B) An elected official who receives an order for the
- 34 resumption of his or her salary whose salary is resumed under subdivision
- 35 (b)(4)(A) of this section shall not receive his or her salary for the period
- 36 that the salary was withheld.

2	SECTION 7. Arkansas Code § 14-47-140(a)(3)(B), concerning

26	which any obstruction or encroachment may have existed or been continued		
27	shall be permitted as a bar or defense against any proceeding or action to		
28	remove or abate it or to punish for its continuance after an order has been		
29	made by the city council or the police district court for its removal or		
30	abatement.

32	SECTION 10. Arkansas Code § 14-54-104(4)(D), concerning additional		
33	powers of cities of the first class, is amended to correct a reference as a		
34	necessary result of Arkansas Constitution, Amendment 80, to read as follows:		
35	(D) To prevent, abate, or remove nuisances of every kind.

Arkansas Code § 14-271-104(f), concerning exemptions for 19 civil penalties, is amended to subdivide subsection (f) for clarity, to read 20 as follows: 21 (f) Neither the State Highway Commission, nor the Arkansas State 22 Highway and Transportation Department, nor their officers or employees, nor 23 the county judges or their road departments are subject to the provisions of 24 this section. This section does not apply to: 25 (1) The State Highway Commission; 26 (2) The Arkansas State Highway and Transportation Department or 27 its officers or employees; or 28 (3) County judges or their road departments. 29 30 SECTION 13. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT. 31 It is the intent of the General Assembly that: 32 (1) The enactment and adoption of this act shall not expressly 33 or impliedly repeal an act passed during the regular session of the Ninety-First General Assembly; 34 35 (2) To the extent that a conflict exists between an act of the

regular session of the Ninety-First General Assembly and this act:

1	(A) The act of the regular session of the Ninety-First
2	General Assembly shall be treated as a subsequent act passed by the General
3	Assembly for the purpose of:
4	(i) Giving the act of the regular session of the
5	Ninety-First General Assembly its full force and effect; and
6	(ii) Amending or repealing the appropriate parts of
7	the Arkansas Code of 1987; and
8	(B) Section 1-2-107 shall not apply; and
9	(3) This act shall make only technical, not substantive, changes
10	to the Arkansas Code of 1987.
