18	benefits paid into the Arkansas State Police Officers' Tier Two Deferred
19	Retirement Option Plan account, is amended to read as follows:
20	(3) Seventy-two percent (72%) Eighty percent (80%) of the
21	monthly retirement benefits that would have been payable had the employee
22	elected to cease employment and receive a service retirement shall be paid
23	into the Arkansas State Police Officers' Tier Two Deferred Retirement Option
24	Plan account.
