36	It is the intent	of the General Assembly that:	

1	(1) The enactment and adoption of this act shall not expressly		
2	or impliedly repeal an act passed during the regular session of the Ninety-		
3	First General Assembly;		
4	(2) To the extent that a conflict exists between an act of the		
5	regular session of the Ninety-First General Assembly and this act:		
6	(A) The act of the regular session of the Ninety-First		
7	General Assembly shall be treated as a subsequent act passed by the General		
8	Assembly for the purpose of:		
9	(i) Giving the act of the regular session of the		
10	Ninety-First General Assembly its full force and effect; and		
11	(ii) Amending or repealing the appropriate parts of		
12	the Arkansas Code of 1987; and		
13	(B) Section 1-2-107 shall not apply; and		
14	(3) This act shall make only technical, not substantive, changes		
15	to the Arkansas Code of 1987.
