I	As used in this subchapter:

4	(2) "Homeowner" means the initial owner and any subsequent owner	
5	of a single-family dwelling;	
6	(3) "Manufacturer" means an entity that produces the components	
7	of a roof system;	
8	(4) "Roof system" means the components to the roof of a single-	
9	family dwelling, including without limitation roof coverings, roof sheathing	
10	roof weatherproofing, shingles, and insulation; and	
11	(5) "Single-family dwelling" means a dwelling constructed for
