7	(1) "Auxiliary law enforcement" officer means the same as

31	SECTION 2. Arkansas Code § 5-77-202 is amended to read as follows:		
32	5-77-202. Law enforcement insignia sales.		
33	(a)(l) It is unlawful to sell official law enforcement insignia to any		
34	person other than a law enforcement officer.		
35	(2) It is unlawful for a person other than a law enforcement		
36	officer to buy official law enforcement insignia.		

1	(b) Before selling official law enforcement insignia, the seller shall		
2	require the buyer to provide identification that legally demonstrates that		
3	the buyer is <u>currently employed as</u> a law enforcement officer <u>or is currently</u>		
4	an appointed auxiliary law enforcement officer.		
5	(c) A violation of this section is a Class A $\frac{A - B}{A}$		
6	felony.		
7	(d) As used in this section;:		
8	(1) "Auxiliary law enforcement officer" means the same as		
9	defined in § 12-9-301; and		
10	(2) "official law enforcement insignia" means those		
11	items relating to the performance of a person's duty as a law enforcement		
12	officer when the items are formally sanctioned by the law enforcement agency		
13	employing the person.		
14			
15	SECTION 3. Arkansas Code § 5-77-205 is amended to read as follows:		
16	5-77-205. Resale of law enforcement vehicles.		
17	(a) Except as provided in subsection (b) of this section, before a law		
18	enforcement vehicle is offered for sale to the public, the seller of the law		
19	enforcement vehicle shall remove from the law enforcement vehicle the:		
20	(1) Lightbar, including any blue lights or blue lens cap;		
21	(2) Spotlight;		
22	(3) Siren;		
23	(4) Law enforcement decals and signage;		
24	(5) Radios; and		
25	(6) Other items associated solely with law enforcement vehicles.		
26	(b) The items required to be removed under subdivisions (a)(1)-(6) of		
27	this section are not required to be removed if the law enforcement vehicle is		
28	sold to a law enforcement agency.		
29	(c) A violation of subsection (a) of this section is a violation and		
30	punishable by a fine of not more than one thousand dollars (\$1,000).
