6	SECTION 3. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.
7	It is the intent of the General Assembly that:
8	(1) The enactment and adoption of this act shall not expressly
9	or impliedly repeal an act passed during the regular session of the Ninety-
10	First General Assembly;
11	(2) To the extent that a conflict exists between an act of the
12	regular session of the Ninety-First General Assembly and this act:
13	(A) The act of the regular session of the Ninety-First
14	General Assembly shall be treated as a subsequent act passed by the General
15	Assembly for the purpose of:
16	(i) Giving the act of the regular session of the
17	Ninety-First General Assembly its full force and effect; and
18	(ii) Amending or repealing the appropriate parts of
19	the Arkansas Code of 1987; and
20	(B) Section 1-2-107 shall not apply; and
21	(3) This act shall make only technical, not substantive, changes
22	to the Arkansas Code of 1987.
