3	also known as the "Arkansas Medical Marijuana Amendment of 2016", § 8(n),		
4	concerning the expiration date of a dispensary license and cultivation		
5	facility license, is amended to read as follows:		
6	(n)(l) A dispensary license and cultivation facility license shall		
7	expire one (1) year after the date of issuance <u>on June 30 of each calendar</u>		
8	year and are renewable on or before June 30 of each calendar year for the		
9	fiscal year beginning July 1.		
10	(2) The commission shall issue a renewal dispensary license or a		
11	renewal cultivation facility license within ten (10) days to any entity who		
12	complies with the requirements contained in this amendment, including without		
13	limitation the payment of a renewal fee.

15	SECTION 3. Pursuant to § 23 of Arkansas Constitution, Amendment 98,		
16	also known as the "Arkansas Medical Marijuana Amendment of 2016", § 9(g),		
17	concerning the expiration date of a registry identification card for a		
18	dispensary agent or cultivation facility agent, is amended to read as		
19	follows:		
20	(g)(l) A registry identification card for a dispensary agent or		
21	cultivation facility agent shall expire one (1) year after the date of		
22	issuance on June 30 of each calendar year and is renewable on or before June		
23	30 of each calendar year for the fiscal year beginning July 1.		
24	(2) A registry identification card of a dispensary agent or		
25	cultivation facility agent expires upon notification to the division by a		
26	dispensary or cultivation facility that the person ceases to work at the		
27	dispensary or cultivation facility.
