7	also known as the "Arkansas Medical Marijuana Amendment of 2016", § 2(14),		
8	concerning the definition of "qualified patient", is amended to read as		
9	follows:		
10	(14)(A) "Qualifying patient" means a person who has been		
11	diagnosed by a physician as having a qualifying medical condition and who has		
12	registered with the department under \S 5 of this amendment.		
13	(B) "Qualifying patient" shall not include a member of the		
14	Arkansas National Guard or the United States military;

16	SECTION 3. Pursuant to § 23 of Arkansas Constitution, Amendment 98,		
17	also known as the "Arkansas Medical Marijuana Amendment of 2016", \S 6(a)(2),		
18	concerning the scope of the Arkansas Medical Marijuana Amendment of 2016, is		
19	amended to read as follows:		
20	(2) Possess, smoke, or otherwise engage in the use of marijuana:		
21	(A) On a school bus;		
22	(B) On the grounds of a daycare center, preschool, primary		
23	or secondary school, college, or university;		
24	(C) At a drug or alcohol treatment facility;		
25	(D) At a community or recreation center;		
26	(E) In a correctional facility;		
27	(F) On any form of public transportation; or		
28	(G) In a public place; or		
29	(H) On any property that is under control of the Arkansas		
30	National Guard or the United State military; or
