## Subtitle

15 TO MAKE LEGISLATIVE CORRECTIONS TO AND  
16 REPEAL OBSOLETE LAWS CONTAINED IN TITLE  
17 27 OF THE ARKANSAS CODE.  
18

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 27-14-101 is amended to remove an obsolete  
23 reference to read as follows:

24 27-14-101. Title.

25 This chapter may be cited as the "~~Uniform~~ Motor Vehicle Administration,  
26 Certificate of Title, and Antitheft Act".  
27

28 SECTION 2. Arkansas Code Title 27, Chapter 14, Subchapter 1, is  
29 amended to add an additional section to contain definitions that are being  
30 transferred from Subchapter 2 to read as follows:

31 27-14-104. Definitions.

32 As used in this chapter:

33 (1) "Bus" means a motor vehicle designed for carrying more than  
34 ten (10) passengers and used for the transportation of persons, or a motor  
35 vehicle, other than a taxicab, designed and used for the transportation of  
36 persons for compensation;



1           (2) “Dealer” means a person engaged in the business of buying,  
2 selling, or exchanging vehicles of a type required to be registered under  
3 this chapter and who has an established place of business for that purpose in  
4 this state;

5           (3) “Essential parts” means all integral and body parts of a  
6 vehicle of a type required to be registered under this chapter, that if  
7 removed, altered, or substituted would tend to conceal the identity of the  
8 vehicle or substantially alter its appearance, model, type, or mode of  
9 operation;

10           (4) “Established place of business” means the place actually  
11 occupied, either continuously or at regular periods, by a dealer or  
12 manufacturer, where the books and records of the business are kept and a  
13 large share of the business is transacted;

14           (5) “Foreign vehicle” means a vehicle not registered in this  
15 state but of a type required to be registered under this chapter and brought  
16 into this state from another state, territory, or country other than in the  
17 ordinary course of business by or through a manufacturer or dealer;

18           (6) “Implement of husbandry” means a vehicle not subject to  
19 registration if used on the highways and designed or adapted exclusively for  
20 timber harvesting or hauling, agricultural, horticultural, or livestock  
21 raising operations, or for lifting or carrying an implement of husbandry;

22           (7) “Manufactured home” means a factory-built structure:

23                   (A) Produced in accordance with the National Manufactured  
24 Housing Construction and Safety Standards Act of 1974, 42 U.S.C. § 5401 et  
25 seq.; and

26                   (B) Designed to be used as a dwelling unit;

27           (8) “Manufacturer” means a person engaged in the business of  
28 constructing or assembling vehicles of a type required to be registered under  
29 this chapter at an established place of business in this state;

30           (9) “Mobile home” means a structure:

31                   (A) Built in a factory before the enactment of the  
32 National Manufactured Housing Construction and Safety Standards Act of 1974,  
33 42 U.S.C. § 5401 et seq.; and

34                   (B) Designed to be used as a dwelling unit;

35           (10)(A) “Motor home” means a motor vehicle designed to provide  
36 temporary living quarters, built onto, or permanently attached to, an

1 integral part of a self-propelled motor vehicle chassis.

2 (B) The vehicle shall contain permanently installed  
3 independent life-enhancement systems;

4 (11) "Motor vehicle" means a vehicle that is self-propelled or  
5 that is propelled by electric power obtained from overhead trolley wires but  
6 not operated upon stationary rails or tracks;

7 (12) "Motorcycle" means a motor vehicle having a saddle for the  
8 use of the rider and designed to travel on not more than three (3) wheels in  
9 contact with the ground, excluding a tractor;

10 (13) "Nonresident" means a person who is not a resident of this  
11 state;

12 (14)(A) "Owner" means a person who holds the legal title of a  
13 vehicle.

14 (B) In the event a vehicle is the subject of an agreement  
15 for the conditional sale or lease with the right of purchase upon performance  
16 of the conditions stated in the agreement and with an immediate right of  
17 possession vested in the conditional vendee or lessee, or in the event a  
18 mortgagor of a vehicle is entitled to possession, then the conditional vendee  
19 or lessee or mortgagor is the owner for the purpose of this chapter;

20 (15) "Person" means a natural person, firm, copartnership,  
21 association, or corporation;

22 (16) "Pneumatic tire" means a tire in which compressed air is  
23 designed to support the load;

24 (17) "Pole trailer" means a vehicle without motive power  
25 designed to be drawn by another vehicle and attached to the towing vehicle by  
26 means of a reach or pole, or by being boomed or otherwise secured to the  
27 towing vehicle, and ordinarily used for transporting long or irregularly  
28 shaped loads such as poles, pipes, or structural members capable, generally,  
29 of sustaining themselves as beams between the supporting connections;

30 (18) "Reconstructed vehicle" means a vehicle of a type required  
31 to be registered under this chapter materially altered from its original  
32 construction by the removal, addition, or substitution of essential parts,  
33 new or used;

34 (19)(A) "Resident" means any person who:

35 (i) Remains in this state for a period of more than  
36 six (6) months;

1                   (ii) Resides in this state due to a change of abode;  
2 or

3                   (iii) Is domiciled in this state on a temporary or  
4 permanent basis.

5                   (B) "Resident" does not include a person who is in this  
6 state as a student;

7                   (20) "School bus" means a motor vehicle that is owned by a  
8 public or governmental agency and operated for the transportation of children  
9 to or from school or that is privately owned and operated for compensation  
10 for the transportation of children to or from school;

11                   (21) "Semitrailer" means a vehicle with or without motive power,  
12 other than a pole trailer, designed for carrying persons or property and for  
13 being drawn by a motor vehicle and so constructed that some part of its  
14 weight and that of its load rests upon or is carried by another vehicle;

15                   (22) "Special mobile equipment" means a vehicle not designed or  
16 used primarily for the transportation of persons or property and incidentally  
17 operated or moved over the highways, including without limitation:

18                   (A) A farm tractor;

19                   (B) Road construction or maintenance machinery;

20                   (C) A ditch-digging apparatus;

21                   (D) A well-boring apparatus; and

22                   (E) A concrete mixer;

23                   (23) "Specially constructed vehicle" means a vehicle of a type  
24 required to be registered under this chapter not originally constructed under  
25 a distinctive name, make, model, or type by a generally recognized  
26 manufacturer of vehicles and not materially altered from its original  
27 construction;

28                   (24) "Street" or "highway" means the entire width between  
29 boundary lines of a roadway publicly maintained when any part of the roadway  
30 is open to the use of the public for purposes of vehicular travel;

31                   (25) "Trailer" means a vehicle with or without motive power,  
32 other than a pole trailer, designed for carrying persons or property and for  
33 being drawn by a motor vehicle and so constructed that no part of its weight  
34 rests upon the towing vehicle;

35                   (26) "Transporter" means a person engaged in the business of  
36 delivering vehicles of a type required to be registered under this chapter

1 from a manufacturing, assembly, or distributing plant to dealers or sales  
 2 agents of a manufacturer;

3 (27) "Truck" means a motor vehicle designed, used, or maintained  
 4 primarily for the transportation of property;

5 (28) "Truck tractor" means a motor vehicle designed and used  
 6 primarily for drawing other vehicles and not so constructed as to carry a  
 7 load other than a part of the weight of the vehicle and load so drawn; and

8 (29) "Vehicle" means a device in, upon, or by which any person  
 9 or property is or may be transported or drawn upon a highway, excepting  
 10 devices moved by human power or used exclusively upon stationary rails or  
 11 tracks.

12  
 13 SECTION 3. Arkansas Code §§ 27-14-201 – 27-14-216, which include some  
 14 outdated statutes and others which will be transferred to a new section in  
 15 Chapter 14, Subchapter 1, are repealed.

~~(a) "Dealer" means every person engaged in the business of buying, selling, or exchanging vehicles of a type required to be registered under this chapter and who has an established place of business for that purpose in this state.~~

~~(b) "Transporter" means every person engaged in the business of delivering vehicles of a type required to be registered under this chapter from a manufacturing, assembly, or distributing plant to dealers or sales agents of a manufacturer.~~

~~(c) "Manufacturer" means every person engaged in the business of constructing or assembling vehicles of a type required to be registered under this chapter at an established place of business in this state.~~

~~27-14-206. Established place of business.~~

~~"Established place of business" means the place actually occupied, either continuously or at regular periods, by a dealer or manufacturer, where his or her books and records are kept and a large share of his or her business is transacted.~~

~~27-14-207. Definitions.~~

33 ~~"Foreign vehicle" means every vehicle of a type required to be~~

 36 ~~through a manufacturer or dealer and not registered in this state.~~

~~27-14-210. Trailer, semitrailer, and pole trailer.~~

~~(a) "Trailer" means every vehicle with or without motive power, other than a pole trailer, designed for carrying persons or property and for being drawn by a motor vehicle and so constructed that no part of its weight rests upon the towing vehicle.~~

~~(b) "Semitrailer" means every vehicle with or without motive power, other than a pole trailer, designed for carrying persons or property and for being drawn by a motor vehicle and so constructed that some part of its weight and that of its load rests upon or is carried by another vehicle.~~

~~(c) "Pole trailer" means every vehicle without motive power designed to be drawn by another vehicle and attached to the towing vehicle by means of a reach or pole, or by being boomed or otherwise secured to the towing vehicle, and ordinarily used for transporting long or irregularly shaped loads such as poles, pipes, or structural members capable, generally, of sustaining themselves as beams between the supporting connections.~~

~~"Special mobile equipment" means every vehicle not designed or used primarily for the transportation of persons or property and incidentally operated or moved over the highways, including farm tractors, road construction or maintenance machinery, ditch-digging apparatus, well-boring apparatus, and concrete mixers. This enumeration shall be deemed partial and shall not operate to exclude other such vehicles which are within the general terms of this section.~~

~~27-14-212. Implements of husbandry.~~

~~"Implements of husbandry" means every vehicle designed or adapted exclusively for timber harvesting or hauling, agricultural, horticultural, or~~

1 ~~livestock raising operations, or for lifting or carrying an implement of~~  
2 ~~husbandry, and, in either case, not subject to registration if used upon the~~  
3 ~~highways.~~

1 SECTION 4. Arkansas Code §§ 27-14-402 – 27-14-404 are amended to  
2 correct obsolete references to read as follows:

3 27-14-402. ~~Commissioner to head.~~ Head of Office of Motor Vehicle.

4 The Office of Motor Vehicle shall be under the control of a ~~civil~~  
5 ~~executive officer to be known as the “Commissioner of Motor Vehicles” who~~  
6 ~~shall be~~ the Director of the Department of Finance and Administration.

7  
8 27-14-403. Powers and duties ~~of commissioner.~~

9 (a) The ~~Commissioner of Motor Vehicles~~ Director of the Department of

27 (b) The ~~commissioner~~ director shall appoint such deputies, subordinate  
28 officers, clerks, investigators, and other employees as may be necessary to

31 Capitol and in such other places in the state as he or she may deem necessary

2 Finance and Administration shall prescribe and provide suitable forms of  
3 applications, certificates of title, registration certificates, and all other  
4 forms requisite or ~~deemed~~ necessary to carry out the provisions of this  
5 chapter and any other laws, the enforcement and administration of which are  
6 vested in the Office of Motor Vehicle.

7  
8           27-14-411. Oaths and signatures.

9           (a) Officers and employees of the Office of Motor Vehicle designated  
10 by the ~~Commissioner of Motor Vehicles~~ Director of the Department of Finance  
11 and Administration are, for the purpose of administering the motor vehicle  
12 laws, authorized to administer oaths and acknowledge signatures.

13           (b) ~~They shall do so without fee~~ Administration of oaths and  
14 acknowledgement of signatures under subsection (a) of this section shall be  
15 performed without fee.

17           27-14-412. Records.

18           (a)(1) All records of the Office of Motor Vehicle, other than those  
19 declared by law to be confidential for the use of the office, shall be open  
20 to public inspection during office hours.

21           (2) The use of lists or other aggregations of compilations of  
22 motor vehicle registration information is restricted to safety recall  
23 notification programs involving motor vehicles and motor vehicle equipment,  
24 other federal and state agency programs, research and statistics involving  
25 motor vehicles in which individual identities are not published, disclosed,  
26 or for any other purpose authorized by the Driver's Privacy Protection Act of  
27 1994, 18 U.S.C. § 2721 et seq., as it existed on January 1, 2015.

28           (3) Motor vehicle registration information shall not be sold,  
29 furnished, or used for solicitation purposes.

30           (b)(1) The ~~Commissioner of Motor Vehicles~~ Director of the Department  
31 of Finance and Administration and such officers of the office as the  
32 ~~commissioner~~ director may designate are authorized to prepare under the seal  
33 of the office and deliver upon request a certified copy of any record of the  
34 office or a noncertified electronic copy of any record of the office.

35           (2) A fee of one dollar (\$1.00) shall be charged for each  
36 certified record authenticated.

1 (3) Every certified copy shall be admissible in any proceeding  
2 in any court in like manner as the original.

3 (4)(A) A party requesting a noncertified electronic record  
4 shall execute a written agreement with the Department of Finance and  
5 Administration that includes the following provisions:

6 (i) An acknowledgment that the party requesting a  
7 record shall comply with all state and federal limits on the use of those  
8 records; and

9 (ii) An agreement that the party seeking to obtain  
10 records shall hold harmless and indemnify the department for any money  
11 damages, punitive damages, criminal fines, civil penalties, court costs, and  
12 attorney's fees awarded to any person or entity by any state or federal court  
13 or by the Arkansas State Claims Commission resulting from any disclosure by  
14 the party of motor vehicle information that is contrary to state or federal  
15 law.

16 (B) A fee of not less than twenty dollars and fifty cents  
17 (\$20.50) nor more than thirty dollars (\$30.00) per one thousand (1,000)  
18 records shall be charged for electronic records.

19 (c) The ~~commissioner~~ director may destroy any records of the office  
20 that have been maintained on file for five (5) years that ~~he or she~~ the  
21 director considers obsolete and of no further service in carrying out the  
22 powers and duties of the office.

23 (d) All fees collected under this section shall be deposited into the  
24 State Central Services Fund for the benefit of the Revenue Division of the  
25 Department of Finance and Administration.

26  
27 SECTION 6. Arkansas Code §§ 27-14-602 and 27-14-603 are amended to  
28 correct obsolete references to read as follows:

29 27-14-602. Registration fees.

30 (a) Except as otherwise provided, all fees shall be paid to the Office  
31 of Motor Vehicle for the registration of motor vehicles, trailers, and  
32 semitrailers under this chapter.

33 (b) The following fees shall be charged under this chapter by the  
34 ~~Commissioner~~ Office of Motor Vehicles ~~Vehicle~~ Vehicle:

- 35 (1) For each certificate of title . . . . . \$2.00
- 36 (2) For each duplicate certificate of title . . . . . 2.00

6 27-14-603. Fee for special numbered license plates.

7 (a) There is levied a service fee of five dollars (\$5.00) to be added  
8 to the regular fee imposed for motor vehicle license plates collected by the  
9 ~~Commissioner Office of Motor Vehicles~~ Vehicle in all instances ~~where~~ in which  
10 a special number is reserved for any motor vehicle license plate applicant.

11 (b) These fees shall be treated as regular license fees and deposited  
12 accordingly as provided by law.

14 SECTION 7. Arkansas Code § 27-14-701(b), concerning exceptions to the  
15 requirements of title, is amended to correct an obsolete reference to read as  
16 follows:

17 (b) When an application accompanied by the proper fee has been made  
18 for registration and certificate of title for a vehicle, ~~it~~ the vehicle may  
19 be operated temporarily pending complete registration upon displaying a  
20 duplicate application, duly verified, or other evidence of the application or  
21 otherwise under rules and regulations promulgated by the ~~Commissioner of~~  
22 Motor Vehicles Director of the Department of Finance and Administration.

24 SECTION 8. Arkansas Code § 27-14-705(b)(2)(C), concerning the contents  
25 of an application for registration and title, is amended to correct an  
26 obsolete reference to read as follows:

27 (C) The certificate of origin shall be on a form to be
