26	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27	
28	SECTION 1. Arkansas Code Title 6, Chapter 51, is amended to add an
29	additional subchapter to read as follows:

31	<u>Subchapter 11 —</u>
32	Procedures to Follow Upon Merger of Crowley's Ridge Technical Institute to
33	East Arkansas Community College
34	
35	<u>6-51-1101. Merger.</u>
36	(a)(l) This subchapter shall govern the merger of Crowley's Ridge

1	Technical Institute and East Arkansas Community College if:
2	(A) The Board of Directors of Crowley's Ridge Technical
3	Institute votes to merge with East Arkansas Community College;
4	(B) The Board of Directors of East Arkansas Community
5	College votes to accept the merger; and
6	(C) The merger is approved under § 6-53-401.
7	(2)(A)(i) When voting to accept a merger under subdivision
8	(a)(l)(B) of this section, the Board of Directors of East Arkansas Community
9	College shall designate a date for the merger to become effective.
10	(ii) The Board of Directors of East Arkansas
11	Community College shall consult the Board of Directors of Crowley's Ridge
12	Technical Institute in determining the date under subdivision (a)(2)(A)(i) of
13	this section.
14	(B) If a merger of Crowley's Ridge Technical Institute and
15	East Arkansas Community College is approved under § 6-53-401, the merger
16	shall become effective on the date designated under subdivision (a)(2)(A)(i)
17	<u>of this section.</u>
18	(b) On the effective date of a merger under subdivision (a)(2) of this
19	section, all statutory authority, powers, duties, functions, records,
20	personnel, property, unexpended balances of appropriations, allocations, or
21	other funds, including the functions of budgeting or purchasing, of Crowley's
22	<u>Ridge Technical Institute shall be transferred to East Arkansas Community</u>
23	<u>College.</u>

25	<u>6-51-1102. Board of directors.</u>
26	On the effective date of a merger under § 6-51-1101(a)(2):
27	(1) The Board of Directors of Crowley's Ridge Technical
28	Institute shall be abolished; and
29	(2) The Board of Directors of East Arkansas Community College
30	shall assume the powers and duties of the Board of Directors of Crowley's
31	<u>Ridge Technical Institute.</u>
32	
33	<u>6-51-1103. Purchasing.</u>
34	(a) Upon the vote of the Board of Directors of Crowley's Ridge
35	<u>Technical Institute to merge with East Arkansas Community College under § 6-</u>
36	51-1101(a)(1)(A) and before the effective date of a merger under § 6-51-

1	<u>1101(a)(2):</u>
2	(1) Purchases by Crowley's Ridge Technical Institute shall be
3	made under the Arkansas Procurement Law, § 19-11-201; and
4	(2) Purchases by East Arkansas Community College may continue to
5	be made under procedures that were applicable to East Arkansas Community
6	<u>College.</u>
7	(b) This section shall not apply if a merger is not subsequently
8	approved under § 6-51-1101(a).

10	6-51-1104. Transfer of assets, obligations, records, personnel,
11	property, unexpended balances, and legal authority.
12	Beginning on the effective date of a merger under § 6-51-1101(a)(2):
13	(1) All property and other rights, claims, and assets of
14	Crowley's Ridge Technical Institute shall be transferred to East Arkansas
15	<u>Community College;</u>
16	(2) All obligations of Crowley's Ridge Technical Institute shall
17	be obligations of East Arkansas Community College;
18	(3)(A) Except as provided in subdivision (3)(B) of this section,
19	all records, personnel, property, unexpended balances, and legal authority
20	shall be transferred from Crowley's Ridge Technical Institute to East
21	<u>Arkansas Community College.</u>
22	(B) If applicable, the personnel transferred from
23	Crowley's Ridge Technical Institute to East Arkansas Community College shall
24	comply with Acts 2017, No. 94, § 1, as amended by this act; and
25	(4) All cash fund balances of Crowley's Ridge Technical
26	Institute transferred to East Arkansas Community College shall be used for

31	6-51-1105. Funding from the Work Force 2000 Development Fund.
32	Beginning on the effective date of a merger under § 6-51-1101(a)(2),
33	funding from the Work Force 2000 Development Fund, which would have been
34	provided to Crowley's Ridge Technical Institute, shall be provided to East
35	Arkansas Community College to fund workforce development, vocational,
36	occupational, and training programs offered by East Arkansas Community

1	<u>College.</u>

3	6-51-1106. Funding from the Federal Adult Basic Education Fund.
4	Beginning on the effective date of a merger under § 6-51-1101(a)(2),
5	funding from the Federal Adult Basic Education Fund, which would have been
6	provided to Crowley's Ridge Technical Institute, shall be provided to East
7	Arkansas Community College.
8	
9	SECTION 2. DO NOT CODIFY.
10	(a) The General Assembly finds that:
11	(1) Significant changes in the day-to-day operations of
12	Crowley's Ridge Technical Institute before the effective date of a merger of
13	Crowley's Ridge Technical Institute to East Arkansas Community College under
14	<u>§ 6-51-1101 may impede the ability of Crowley's Ridge Technical Institute to</u>
15	merge seamlessly into East Arkansas Community College; and
16	(2) Additional guidance and restrictions are necessary to assure
17	<u>a smooth transition to the new institutional structure of East Arkansas</u>
18	Community College provided for by this act.
19	(b) Except as provided in subsection (c) of this section, upon the
20	vote of the Board of Directors of Crowley's Ridge Technical Institute to
21	<u>merge with East Arkansas Community College under § 6-51-1101(a)(1)(A) and</u>
22	before the effective date of a merger under § 6-51-1101(a)(2), Crowley's
23	<u>Ridge Technical Institute shall not:</u>

14	SECTION 7. EMERGENCY CLAUSE. It is found and determined by the
15	General Assembly of the State of Arkansas that under current law the Board of
16	<u>Directors of Crowley's Ridge Technical Institute may choose to merge with</u>
17	East Arkansas Community College; that if the board chooses to pursue such a
18	merger, it is critically important to the students and faculty of both
19	institutions that the merger occur in an organized and efficient manner; and
20	that this act is immediately necessary to allow a smooth transition in the
21	event of a merger of Crowley's Ridge Technical Institute and East Arkansas
22	Community College. Therefore, an emergency is declared to exist, and this
23	act being immediately necessary for the preservation of the public peace,
24	health, and safety shall become effective on:
25	(1) The date of its approval by the Governor;
26	(2) If the bill is neither approved nor vetoed by the Governor,
27	the expiration of the period of time during which the Governor may veto the
28	<u>bill; or</u>
29	(3) If the bill is vetoed by the Governor and the veto is
30	overridden, the date the last house overrides the veto.
