11 THE DEAF WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION
12 TO THOSE FUNDS APPROPRIATED BY ACT 113 OF 2016; AND
13 FOR OTHER PURPOSES.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
25 appropriated, to the Department of Education - Arkansas School for the Deaf,
26 to be payable from the School for the Deaf Fund Account, for personal
27 services, operating expenses and special maintenance of the Department of
28 Education - Arkansas School for the Deaf - State Operations which shall be
29 supplemental and in addition to those funds appropriated in Section 3 of Act
30 113 of 2016, the following:

8 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

9 authorized by this act shall be limited to the appropriation for such agency

10 and funds made available by law for the support of such appropriations; and

11 the restrictions of the State Procurement Law, the General Accounting and

12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

13 Procedures and Restrictions Act, or their successors, and other fiscal

14 control laws of this State, where applicable, and regulations promulgated by

15 the Department of Finance and Administration, as authorized by law, shall be

16 strictly complied with in disbursement of said funds.

17

18 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General

19 Assembly that any funds disbursed under the authority of the appropriations

20 contained in this act shall be in compliance with the stated reasons for

21 which this act was adopted, as evidenced by the Agency Requests, Executive

22 Recommendations and Legislative Recommendations contained in the budget

23 manuals prepared by the Department of Finance and Administration, letters, or

24 summarized oral testimony in the official minutes of the Arkansas Legislative

25 Council or Joint Budget Committee which relate to its passage and adoption.

27 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General

28 Assembly, that funds provided by the General Assembly for the operations of

29 the Department of Education - Arkansas School for the Deaf are, due to

30 unforeseen circumstances, insufficient for the Department of Education -

31 Arkansas School for the Deaf to continue to provide essential governmental

32 services; that the provisions of this act will provide the necessary monies

33 for the Department of Education - Arkansas School for the Deaf to continue

34 such services; and that a delay in the effective date of this Act could work

35 irreparable harm upon the proper administration and provision of essential

36 governmental programs. Therefore, an emergency is hereby declared to exist

1 and this Act being necessary for the immediate preservation of the public
 2 peace, health and safety shall be in full force and effect from and after the
 3 date of its passage and approval.

4 If the bill is neither approved nor vetoed by the Governor, it shall
 5 become effective on the expiration of the period of time during which the
 6 Governor may veto the bill. If the bill is vetoed by the Governor and the
 7 veto is overridden, it shall become effective on the date the last house
 8 overrides the veto.
