4	Arkansas Plant Act of 1917, is amended to add an additional subsection to		
5	read as follows:		
6	(c) Moneys collected through a civil penalty assessed by the board		
7	shall be distributed as follows:		
8	(1) For amounts up to one thousand dollars (\$1,000), as		
9	currently used, including funding for the Arkansas State Plant Board		
10	Scholarship program; and		
11	(2) For amounts more than one thousand dollars (\$1,000):		
12	(A) The first one thousand dollars (\$1,000) of the		
13	assessed penalty for scholarships through the Arkansas State Plant Board		
14	Scholarship program; and		
15	(B) The remainder divided as follows:		
16	(i) Fifty percent (50%) deposited into the State		
17	Treasury and credited to the General Revenue Fund Account; and		
18	(ii) Fifty percent (50%) deposited into the Arkansas		
19	Agriculture Department Fund Account to be used for:		
20	(a) Education and training of employees of the		
21	University of Arkansas Division of Agriculture and of agencies administered		
22	by the division; and		
23	(b) Other programs developed by the division.
