- 21 (a)(1) The Prescriptive Authority Advisory Committee is created as an 22 advisory committee to the Arkansas State Board of Nursing.
- 23 (2) The committee shall assist the board in implementing the 24 provisions of this chapter regarding prescriptive authority.
- 25 <u>(3) The committee shall conduct hearings and make</u> 26 <u>recommendations to the board on issues and violations of § 17-87-101 et seq.</u>
 - (b) The board Governor shall appoint six (6) members, to be approved by the Governor, who have the following qualifications:
- 29 (1) Four (4) members shall be advanced practice registered
 30 nurses at least three (3) of whom who hold certificates of prescriptive
 31 authority and an active United States Drug Enforcement Administration number;
- 32 (2) One (1) member shall be a licensed physician who has been 33 involved in a collaborative practice with an advanced practice registered 34 nurse for at least five (5) years; and
- 35 (3) One (1) member shall be a licensed pharmacist who has been licensed for at least five (5) years.
