18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code § 27-35-112(a), concerning towing vehicl	es
21	licensed in other states, is amended to read as follows:	
22	(a)(1) No $\underline{A}$ vehicle licensed in another state for use as a wrecke	r or
23	similar towing vehicle <del>shall</del> <u>may</u> be used to tow <del>any</del> <u>an</u> automobile or tru	ck in
24	this state <del>unless the state in which the wrecker or other towing vehicle</del>	<del>is</del>
25	licensed permits Arkansas-licensed wreckers and towing vehicles to tow	
26	automobiles and trucks in that state only if:	
27	(1) The wrecker or similar towing vehicle licensed in anoth	<u>er</u>
28	state is requested by the owner or operator of the vehicle to be towed;	
29	(2) The vehicle is not being towed as a result of a collisi	<u>on</u>
30	that occurred within this state; and	
31	(3) The vehicle is being towed:	
32	(A) In either direction across the border between Ark	<u>ansas</u>
33	and a neighboring state; or	
34	(B) Through Arkansas in transit to another state.	
35	(2) Subsection (a) of this section shall not apply to a veh	<u>icle</u>
36	used as a wrecker or similar towing vehicle if the vehicle:	

1	(A) Is licensed in an incorporated city or town in a state
2	adjoining an Arkansas city or incorporated town that is divided by a state
3	<u>line; and</u>
4	(B) The city or town in the adjoining state is of greater
5	population than the Arkansas city or town.
6	(2) For the purpose of determining whether another state permits
7	Arkansas-licensed wreckers and towing vehicles to tow automobiles and trucks
8	in that state, any limitation on Arkansas-licensed wreckers and towing
9	vehicles to tow automobiles and trucks imposed by a county, parish, city, or
10	other political subdivision of that state shall be deemed an action of that
11	state.
