27	SECTION 1. Arkansas C	ode § 15-12-103(b)(1)(A),	, concerning the

30	(b) After deducting t	hree percent (3%) of the	revenues for
31	distribution to the Constitu	tional Officers Fund and	the State Central
32	Services Fund to be used for	the purposes as provided	d by law, the Treasurer
33	of State shall credit the net amount thereof of the revenues as follows:		
34	(1)(A) Eighty p	ercent (80%) Sixty percer	nt (60%) of the net

9	of revenues derived from the additional tax levied on deeds, instruments, an		
10	writings, is amended to add an additional subdivision to read as follows:		
11	(4) Twenty percent (20%) of the net amount shall be credited to		
12	the Arkansas Housing Trust Fund to be used as follows:		
13	(A) Ninety percent (90%) of the funds may be used for any		
14	purpose stated in § 15-5-1708; and		
15	(B)(i) Ten percent (10%) of the funds may be used for the		
16	purpose of providing adequate, safe, and affordable housing for veterans.		
17	(ii) However, any funds designated under subdivision		
18	(b)(4)(B)(i) of this section that have not been used as provided under		
19	subdivision (b)(4)(B)(i) of this section by the end of each fiscal year may		
20	be used for any purpose stated in § 15-5-1708.
