26	(c) The plan created under this section shall include provisions for:		
27	(1) Controlling invasive feral hogs will take a long-term,		
28	cooperative approach with aggressive and effective strategies;		
29	(2) Four (4) tenets for effective population reduction and		
30	eradication efforts as the core principles to steer policy and guide the		
31	actions of the partnership, as follows:		
32	(A) Developing a multi-partner alliance to identify and
