17	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19	SECTION 1. Acts 2017, No 313, § 3, is amended to read as follows:

23	(a)(l) A small farm winery licensee with a wine wholesale permit under
24	<i>§ 3-5-1602(c)(1)(E) may ship small farm winery wine under this subchapter to</i>
25	a private resident without the private resident having been physically
26	present or having made an in-person purchase at the small farm winery if the
27	shipment includes only small farm winery wine.
28	(2) Additional shipping registration of a small farm winery is
29	not required for a shipment under subdivision (a)(l) of this section.
30	(b) A private resident shall provide identification to the small farm
31	winery proving that he or she is twenty-one (21) years of age or older.
32	(c) A small farm winery may ship only one (l) case of small farm
33	winery wine per private resident in any month.
34	(d) A small farm winery shipping under this subchapter shall ensure
35	that all containers of small farm winery wine delivered within this state are
36	conspicuously labeled as follows:

1 "CONTAINS ALCOHOL: SIGNATURE OF PERSON AGE 21 OR OLDER REQUIRED FOR 2 DELIVERY". (e)(1) A small farm winery shall collect all sales taxes and excise 3 4 taxes due on a sale to an individual of this state as if the sale took place 5 on the premises of the small farm winery, including without limitation taxes 6 under §§ 3-5-1605, 3-7-104, 3-7-111, and 3-7-201. 7 (2) Taxes collected by the small farm winery shall be submitted 8 to the Department of Finance and Administration as directed without limitation under §§ 3-5-1605, 3-7-104, 3-7-111, and 3-7-201. 9 10 (3) A small farm winery shall source the collection of sales and 11 use taxes to the purchaser's delivery address in accordance with § 26-52-12 521(b)(2). 27	requirements specified in subdivision (c)(l) of this section shall draw a
28	number between one (1) and the number of eligible licensees.
29	(3) The drawing shall be conducted by the Director of the
30	Alcoholic Beverage Control Division.
31	(4) The individual of record with the division designated as the
32	permit holder for the eligible small farm winery shall be present for the
33	drawing at the location chosen by the director to be awarded a small farm
34	winery private-resident shipping permit if selected by the drawing.
35	(5) Position numbers may not be assigned or transferred.

13	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
14	General Assembly of the State of Arkansas that this act amends Acts 2017, No
15	313, § 3, that became effective March 2, 2017, as a result of an emergency
16	clause; Act 313 of 2017 requires immediate action by the Alcoholic Beverage
17	Control Board, the Director of the Alcoholic Beverage Control Division, and
18	small farm winery license holders; the language of this bill alters the
19	timelines imposed by Act 313 of 2017 and the procedure by which permits are
20	issued; without the immediate enactment of this act, confusion will exist as
21	to the procedures to be implemented for issuing permits under Act 313 of 2017
22	and unnecessary costs will be incurred to comply with Act 313 of 2017.
23	Therefore, an emergency is declared to exist, and this act being immediately
24	necessary for the preservation of the public peace, health, and safety shall
25	become effective on:
26	(1) The date of its approval by the Governor;
27	(2) If the bill is neither approved nor vetoed by the Governor,
28	the expiration of the period of time during which the Governor may veto the
29	<u>bill; or</u>
30	(3) If the bill is vetoed by the Governor and the veto is
31	overridden, the date the last house overrides the veto.
