6	thousand dollars (\$50,000) seventy-five thousand dollars (\$75,000) shall be		
7	awarded by competitive sealed bidding unless a determination is made in		
8	writing by the agency procurement official or the State Procurement Director		
9	that this method is not practicable and advantageous and specifically states		
10	the reasons that this method is not practicable and advantageous.

12	SECTION 3. Arkansas Code § 19-11-234(b)(1), concerning competitive		
13	bidding under the Arkansas Procurement Law, is amended to read as follows:
