17	the day-to-day operations and maintenance of the Northeast Arkansas District		
18	Fair fairgrounds.		
19	(3) Members of the board shall serve four-year terms, and any		
20	vacancies arising in the board membership shall be filled in the same manner		
21	as were the original appointments.		
22	(4)(A) The members of the advisory board shall elect a		
23	President, Vice-President, and Secretary-Treasurer of the advisory board.		
24	(B) An officer elected under subdivision (a)(4)(A) of this		
25	section shall serve one-year terms in office and may be reelected not to		
26	exceed eight (8) years.		
27	(5) A quorum of the advisory board shall be eight (8) members.		
28	(b)(1) There is created an executive board that shall be composed of		
29	the President and Secretary-Treasurer of the advisory board and the President		
30	and Secretary-Treasurer of the county fair association of the county in the		
31	Northeast Arkansas District in which the Northeast Arkansas District Fair is		
32	<u>located.</u>		
33	(2) The executive board shall conduct the day-to-day operations		
34	and maintenance of the Northeast Arkansas District Fair fairgrounds.		
35	(3) The advisory board may override a decision of the executive		
36	board with a two-thirds (2/3) vote of a quorum.

2	the Arkansas Livestock and Poultry Commission and otherwise conducted in the		
3	same manner as other district fairs.		
4	(2) The location of the Northeast Arkansas District Fair shall		
5	be in Graighead County.		
6	(c)(d)(1) The board shall annually select a chair from among its		
7	membership The members of the advisory board shall serve four-year terms.		
8	(2) A vacancy on the board shall be filled in the same manner as		
9	the original appointment.		
10	(d)(e)(1) After each federal decennial census, the membership on the		
11	board shall be reapportioned among the counties listed in subsection (a) of		
12	this section in such manner as to reflect the proportionate population of		
13	cach county relating to the district as a whole The advisory board shall meet		
14	at a central location one (1) time each month.		
15	(2) The president of the advisory board shall call the monthly		
16	meeting of the advisory board.		
17	(f)(1) The location of the district fair shall be determined by the		
18	advisory board.		
19	(2) The advisory board shall establish the length of time that		
20	the fair will be held in a county, not to exceed three (3) years.		
21	(3) The advisory board shall provide notice to the current host		
22	county one (1) year before changing the location of the district fair.		
23	(4) The advisory board may change the location or the date or		
24	both of the district fair through a two thirds (2/3) vote of a quorum.		
25	(g) The current host count of the district fair shall submit financial		
26	statements to the advisory board at the monthly meeting of the advisory		
27	<u>board.</u>

29	SECTION 2. DO NOT CODIFY. <u>First meeting.</u>		
30	(a) The current president of the Northeast Arkansas District Fair		
31	Advisory Board shall call a meeting at a central location between November i		
32	2013 and December 20,2017.		
33	(b) At the meeting called under subsection (a) of this section, the		
34	members of the advisory board shall elect a President, Vice-President, and		
35	Secretary-Treasurer of the advisory board.
