13	AN AMENDMENT TO THE ARKANSAS CONSTITUTION CONCERNING
14	THE PRESENTATION OF VALID PHOTOGRAPHIC IDENTIFICATION

16	PHOTOGRAPHIC IDENTIFICATION WHEN VOTING IN PERSON OR
17	WHEN CASTING AN ABSENTEE BALLOT; AND PROVIDING THAT
18	THE STATE OF ARKANSAS ISSUE PHOTOGRAPHIC
19	IDENTIFICATION AT NO CHARGE TO ELIGIBLE VOTERS

24	AN AMENDMENT TO THE ARKANSAS CONSTITUTION
25	CONCERNING VOTER IDENTIFICATION WHEN
26	CASTING A BALLOT.

29	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIRST GENERAL
30	ASSEMBLY OF THE STATE OF ARKANSAS AND BY THE SENATE, A MAJORITY OF ALL
31	MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:
32	
33	That the following is proposed as an amendment to the Constitution of
34	the State of Arkansas, and upon being submitted to the electors of the state
35	for approval or rejection at the next general election for Representatives
36	and Senators, if a majority of the electors voting thereon at the election

1	adopt the amendment, the amendment shall become a part of the Constitution of
2	the State of Arkansas, to wit:
3	
4	SECTION 1. Arkansas Constitution, Article 3, § 1, is amended to read
5	as follows:
6	§ 1. Qualifications of electors.
7	(a) Except as otherwise provided by this Constitution, any person may
8	vote in an election in this state who is:
9	(1) A citizen of the United States;
10	(2) A resident of the State of Arkansas;
11	(3) At least eighteen (18) years of age; and
12	(4) Lawfully registered to vote in the election.
13	(b)(1) In addition to the qualifications under subsection (a) of this
14	section, the General Assembly shall provide by law that a voter shall:
15	(A) Present valid photographic identification before
16	receiving a ballot to vote in person; and
17	(B) Enclose a copy of valid photographic identification
18	with his or her ballot when voting by absentee ballot.
19	(2) The General Assembly shall establish by law the types of
20	photographic identification that a person may present to comply with
21	subdivision (b)(1) of this section.
22	(c) The State of Arkansas shall issue photographic identification at
23	no charge to an eligible voter who does not have a form of photographic
24	identification meeting the requirements of the law enacted by the General
25	Assembly under this section.
26	(d)(l)(A) A voter unable to present valid photographic identification
27	when voting in person shall be permitted to vote a provisional ballot.
28	(B) An absentee ballot that is not accompanied by a copy
29	of valid photographic identification shall be considered a provisional
30	<u>ballot</u> .
31	(2) A provisional ballot under subdivision (d)(l) of this
32	section shall be counted only if the voter subsequently certifies the
33	provisional ballot in a manner provided by law.
34	(e)(1) The General Assembly shall implement the provisions of this
35	amendment by law.

(2) The General Assembly may provide by law for exceptions to

1	the requirement that a voter:
2	(A) Present valid photographic identification before
3	receiving a ballot to vote in person; and
4	(B) Enclose a copy of valid photographic identification
5	with his or her ballot when voting by absentee ballot.
6	(f) A voter meeting the requirements of this section also shall comply
7	with all additional laws regulating elections necessary for his or her vote
8	to be counted.

10	SECTION 2. BALLOT TITLE AND POPULAR NAME. When this proposed
11	amendment is submitted to the electors of this state on the general election
12	ballot:
13	(1) The title of this joint resolution shall be the ballot
14	title; and
15	(2) The popular name shall be "A Constitutional Amendment Adding
16	as a Qualification to Vote that a Voter Present Certain Valid Photographic
17	Identification When Casting a Ballot In Person or Casting an Absentee
18	Ballot."
