           11.(j) Appoint Serve as the Speaker Pro Tempore for the next Speaker

     of the House following his or her term as Speaker of the House. In the event

     that the outgoing Speaker of the House will no longer be a member of the

     House of Representatives following his or her term as Speaker of the House,

     the Speaker-Designate shall appoint, at the beginning of each session, a

     member of the House of Representatives to serve as Speaker Pro Tempore. The

     Speaker Pro Tempore shall serve during the absences of the Speaker and shall
     perform the Speaker's duties. The Speaker Pro Tempore shall not serve more
