24	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIRST GENERAL

27	SECTION 1. Rule 10.(a) of the Rules of the House of Representatives of
28	the Ninety-First General Assembly of the State of Arkansas is amended to add
29	an additional subdivision to read as follows:
30	10.(a)(7) No member of the House of Representatives may serve as
31	Speaker of the House of Representatives more than one (1) two-year term.

33	SECTION 2. Rule 11.(j) of the Rules of the House of Representatives of
34	the Ninety-First General Assembly of the State of Arkansas is amended to read
35	as follows:
36	ll.(j) Appoint Serve as the Speaker Pro Tempore for the next Speaker of

1	the House of Representatives following his or her term as Speaker of the
2	House of Representatives. In the event that the outgoing Speaker of the
3	House of Representatives will no longer be a member of the House of
4	Representatives following his or her term as Speaker of the House of
5	Representatives, the Speaker-Designate shall appoint, at the beginning of
6	each session, a member of the House <u>of Representatives</u> to serve as Speaker
7	Pro Tempore. The Speaker Pro Tempore shall serve during the absences of the
8	Speaker of the House of Representatives and shall perform the Speaker's
9	duties. The Speaker Pro Tempore shall not serve more than ten (10)
10	consecutive legislative days without the consent of the House ${ m of}$
11	<u>Representatives</u> , or beyond adjournment. The Speaker of the House <u>of</u>
12	Representatives may appoint four (4) Assistant Speakers Pro Tempore;
