24	SECTION 1. Arkan	nsas Code § 6-53-103(7)(B), conce	rning the definition

31	SECTION 2. Arkan	nsas Code § 6-53-302, concerning	the local

3	(B) The board of trustees of the four-year institution of		
4	higher education or the board of trustees of the university system shall		
5	perform the functions, duties, and responsibilities of the former governing		
6	board of the technical college.		
7	(2) After a merger under subdivision (k)(l) of this section, the		
8	former governing board of the technical college shall become a board of		
9	visitors performing the functions as determined by the board of trustees of		
10	the four-year institution of higher education or the board of trustees of the		
11	university system.		
12	(3) Members of the board of visitors shall:		
13	(A) Be appointed by the Governor subject to the		
14	confirmation of the Senate;		
15	(B) Serve terms of seven (7) years;		
16	(C) Possess the qualifications under subsection (c) of		
17	this section; and		
18	(D) Be subject to the restrictions under subsection (d) of		
19	this section.

21	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the		
22	General Assembly of the State of Arkansas that clearly established procedures		
23	are a necessary component of a successful merger of a technical college with		
24	a four-year institution of higher education or a university system; that		
25	clarity is needed in the law regarding the general authority of the board of		
26	trustees and the respective roles of a governing board and a board of		
27	visitors when a technical college merges with a four-year institution of		
28	higher education or a university system; and that this act is immediately		
29	necessary to ensure that mergers of a technical college with a four-year		
30	institution of higher education or a university system can proceed without		
31	confusion as to the role of the respective boards that would otherwise cause		
32	harm to the merging institutions. Therefore, an emergency is declared to		
33	exist, and this act being immediately necessary for the preservation of the		
34	public peace, health, and safety shall become effective on:		
35	(1) The date of its approval by the Governor;		
36	(2) If the bill is neither approved nor vetoed by the Governor,		

1	the expiration of the period of time during which the Governor may veto the		
2	bill; or		
3	(3) If the bill is vetoed by the Governor and the veto is		
4	overridden, the date the last house overrides the veto.
