20	expected to be detrimental to the public safety, including records or other		
21	information concerning emergency or security plans, procedures, risk		
22	assessments, studies, measures, or systems;		
23	(2) Records or other information relating to the number of		
24	licensed security officers, certified law enforcement officers, or other		
25	security personnel employed by or contracting with a state-supported		
26	institution of higher education, as well as any personal information about		
27	those individuals; and		
28	(3) Any other records or other information of a state-supported		
29	institution of higher education relating to or having an impact upon the		
30	security or safety of persons, structures, facilities, or other		
31	infrastructure.
